

## **DEED OF EASEMENT**

### **Temporary Easement 23-T1 Area: 0.055 Acre +/-**

Situated in the State of Ohio, County of Pickaway, Township of Harrison, and Located in Section 13, Township 3, Range 22, and being part of that 49.049 acre tract conveyed to Hart Columbus Logistics LLC by deed of record found in OR Volume 767, at Page 5278 (all references refer to the records of the Recorder's Office, Pickaway County, Ohio) and being described as follows:

Commencing at a northeasterly corner of a 32.192 acre tract conveyed to BASF Corporation by deed of record found in OR Volume 0719, at Page 2330, being common to the northeasterly corner of the Rickenbacker Intermodal Campus South – Logistics Court & Lot 1 Plat of Record found in OR Volume 2, at Page 363 in the Recorder's Office of Pickaway County, said point being on a westerly right of way line of Logistics Court;

Thence South 02°32'01" West continuing along said westerly right of way line of Logistics Court, for a distance of 21.56 feet to a point on the easterly line of said 32.192 acre tract, being a common line with said westerly right of way line of Logistics Court;

Thence South 87°27'59" East leaving said right of way line and proceeding for a distance of 60.00 feet to a point on the westerly line of said 49.049 acre tract, being a common line with the easterly right of way line of said Logistics Court;

Thence South 87°27'59" East, leaving said right of way line and proceeding across said 49.049 acre tract, for a distance of 30.00 feet to a point on an easterly line of an existing 30.00 foot easement of record, said point being the **TRUE POINT OF BEGINNING**;

Thence North 02°32'01" East, through said 49.049 acre tract and along said existing 30.00 foot easement line, for a distance of 12.11 feet to a point on said existing easement line;

Thence through said 49.049 acre tract, by the following three (3) courses and distances:

- 1.) South 86°26'17" East, for a distance of 206.97 feet to a point;
- 2.) South 03°33'43" West, for a distance of 11.14 feet to a point on the proposed sanitary sewer easement;
- 3.) North 86°42'27" West, for a distance of 206.98 feet along the proposed sanitary sewer easement to a point on an easterly line of said existing 30.00 foot easement, said point being the **TRUE POINT OF BEGINNING**, and containing within said bounds 0.055 acres of land, more or less.

Bearings for the above description are based on the line found between the monument at the center of Rickenbacker Road at S.R. 762 – Ashville Pike and the monument found at the center of Rickenbacker Road at the township line between Harrison Township and Madison Township, being South 86°35'55" East as found by VRS/GPS survey performed on December 27, 2017.

This legal Description of the Easement Area is also depicted on the one (1) page attachment, Exhibit-A, which is fully incorporated for reference as if rewritten.
