Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 17 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 64 of the Foxboro Village Section 2 Subdivision as recorded in Plat Book 51, Page 106, as conveyed to Janet Shepherd by deed of record in Official Record 32533 G09, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the right side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book\_\_\_\_, Page\_\_\_\_;

**Beginning** at the northwest corner of said Lot 64, being 40.00 feet right of Hard Road centerline station 135+54.34;

Thence South 87 degrees 39 minutes 05 seconds East, a distance of 120.00 feet along the northerly line of said Lot 64, and along the existing southerly right-of-way line of Hard Road, to the northeast corner of said Lot 64, being 40.00 feet right of station 136+74.34;

Thence South 02 degrees 20 minutes 55 seconds West, a distance of 10.00 feet along the easterly line of said Lot 64 to a point being 50.00 feet right of station 136+74.34;

Thence North 85 degrees 12 minutes 01 seconds West, a distance of 116.91 feet across said Lot 64 to a point in the westerly line of said Lot 64, being 45.00 feet right of station 135+57.54;

Thence North 30 degrees 14 minutes 11 seconds West, a distance of 5.93 feet along the westerly line of said Lot 64, to the **Point of Beginning**, containing 0.020 acres, more or less;

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.
