[Surveyor's description of the premises follows]

Situate in Half Section 30, Township 5N, Range 22W, in the City of Columbus, County of Franklin, State of Ohio, and being part of Lot 45 of Shera's Addition as recorded in Plat Book 7, page 212 as conveyed to James E. Skipper, Hattie Skipper and Mattie M. Skipper by deed recorded in Deed Book 3553, page 938 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at the northeast corner of said Lot 45, said point being the intersection of the west right of way line of Ann Street (40' public right of way) with the south right of way line of an alley (20' public right of way), 20.00 feet left of centerline Station 208+52.68;

thence along the east line of said Lot 45 and the west right of way line of said Ann Street, South three degrees forty-four minutes thirty-five seconds West (S03°44'35"W), for thirty and 25/100 feet (30.25') to the southeast corner of said Lot 45 and the northeast corner of Lot 44 of said Shera's Addition, 20.00 feet left of centerline Station 208+22.43;

thence along the south line of said Lot 45 and the north line of said Lot 44, North eighty-six degrees nine minutes forty-one seconds West (N86°09'41"W), for six and 00/100 feet (6.00') to a point, 26.00 feet left of centerline Station 208+22.44;

thence leaving said lines across said Lot 45, North three degrees forty-four minutes thirty-five seconds East (N03°44'35"E), for thirty and 25/100 feet (30.25') to a point on the north line of said Lot 45 and the south right of way line of said alley, 26.00 feet left of centerline Station 208+52.69;

thence along said lines, South eighty-six degrees nine minutes forty-one seconds East (S86°09'41"E), for six and 00/100 feet (6.00') to the POINT OF BEGINNING.

The above described area contains 0.004 acres (181.50 sq. ft.), more or less, of which the present road occupies 0.000 acres, more or less, which is part of the Franklin County Auditor's Permanent Parcel Number 010-045264.

The stations and offsets of the above description are measured from the proposed centerline of construction for Ann Street.

The bearings shown hereon are based on the centerline of Ann Street from Frebis Avenue to Whittier Street as being North 03° 44' 35" East, from an adjusted field survey using multiple VRS observations and/or direct GNSS measurements from Franklin County monuments FRANK 43, 973, and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum of 1983 (NSRS 2007) scaled to ground by 1.0000488019 about the projection false northing and easting (0, 1968500).
