Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.012 acres within a 1.117 acre parcel conveyed to THE LURIE FAMILY LIMITED PARTNERSHIP an Ohio Limited Partnership, as described in Instrument Number 200103300065530 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Ohio Department of Transportation, and being located within the following described points in the boundary thereof:

Commencing for reference at Franklin County Geodetic Survey (FCGS) monument #6671 found in the centerline of Hamilton Road (120' R/W), being at Station 79+57.60 and being South 3°28'21" West a distance of 1593.02 feet, along the centerline of right-of-way of Hamilton Road, from Franklin County Geodetic Survey (FCGS) monument #6666 found;

Thence from the said FCGS #6671 and along the said centerline of right-of-way of Hamilton Road, North 3°28'21" East a distance of 677.27 feet to a point at Station 86+34.87;

Thence South 86°31'39" East a distance of 60.00 feet to an iron pin set on the existing easterly right-of-way of Hamilton Road and the northwest property corner of the 32.117 acre tract conveyed to Meijer Stores LP in Instrument Number 200104040069341, and the easterly line of a tract conveyed to the City of Columbus in Deed Book 3791, Page 18, being 60.00 feet right of Station 86+34.87 and the True Point of Beginning;

Thence along the said easterly existing right-of-way of Hamilton Road as conveyed to the said City of Columbus in Deed Book 3791, Page 18, North 3°28'21" East, a distance of 40.21 feet to an iron pin set and being 60.00 feet right of centerline Station 86+75.09;

Thence across the said 1.117 acre tract, South 43°12'45" East a distance of 21.99 feet to an iron pin set and being 76.00 feet right of centerline Station 86+60.00;

Thence across the said 1.117 acre tract, South 3°28'21" West, a distance of 25.13 feet to an iron pin set in the northerly property line of the said 32.117 acre tract and being 76.00 feet right of centerline Station 86+34.87;

Thence along the northerly property line of the said 32.117 acre tract, North 86°31'48" West a distance of 16.00 feet to the True Point of Beginning, containing 0.012 acres, more or less.

The above described parcel contains 0.012 acres, more or less, including the present road occupies which is 0.000 acres, for a net take of 0.012 acres, more or less from Auditors Permanent Parcel Number 545-125868.

All iron pins set are 5/8 inch rebar (30 inches long) with a yellow plastic cap stamped "R/W Dynotec, Inc." and are to be set after construction.

Grantor claims title by Instrument Number 200103300065530, in the Franklin County Recorder's Office.

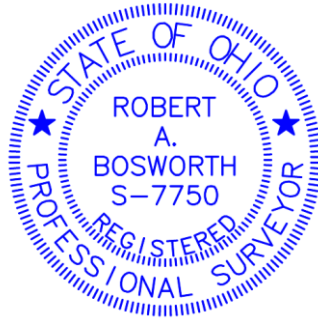
