## PARCEL 46-T TEMPORARY EASEMENT

Tate**, of record in Official Record 14844, page H19, all records referenced herein are on file at the Office of the Recorder for Franklin County, Ohio, being a parcel on the right side of the proposed centerline of construction for James Road, as seen on the centerline plat for James Road, of record in Plat Book \_\_\_\_\_, page \_\_\_\_\_, said parcel being more particularly bounded and described as follows:

Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southwest corner of said ½ Section 29, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence North 04 degrees 27 minutes 26 seconds East, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 29, a distance of 510.12 feet to an angle point, said point being 9.00 feet left of James Road proposed centerline of construction Station 109+09.33;

Thence North 04 degrees 26 minutes 27 seconds East, continuing along the existing centerline of right-of-way for James Road and continuing along the west line of said ½ Section 29, a distance of 568.61 feet to a point, said point being 8.95 feet left of James Road proposed centerline of construction Station 114+77.94;

Thence **South 85 degrees 33 minutes 33 seconds East**, along a line perpendicular to the previous course, a distance of **40.00 feet** to a point on the existing east right-of-way line for said James Road, as established by said Easthampton Addition, being the southwest corner of said Lot 12, and being the northwest corner of Lot 11 of said Easthampton Addition, as said Lot is described in a deed to Hayman Ohio, LLC, of record in Instrument Number 200912070175978, said point being 31.05 feet right of James Road proposed centerline of construction Station 114+77.93;

Thence South 85 degrees 33 minutes 33 seconds East, along the south line of said Lot 12 and along the north line of said Lot 11, a distance of 7.00 feet to an iron pin set on the proposed east right-of-way line for said James Road, said iron pin set being 38.05 feet right of James Road proposed centerline of construction Station 114+77.93, and said iron pin set being the TRUE POINT OF BEGINNING for the herein described temporary easement;

Thence **North 04 degrees 26 minutes 27 seconds East**, along the proposed east right-of-way line for said James Road and across said Lot 12, a distance of **50.00 feet** to an iron pin set on the north line of said Lot 12, being the south line of Lot 13 of said Easthampton Addition, as said Lot is described in a deed to Joseph F. Lascola, of record in Instrument Number 200809090136405, said iron pin set being 38.05 feet right of James Road proposed centerline of construction Station 115+27.93;

Thence South 85 degrees 33 minutes 33 seconds East, along the north line of said Lot 12 and along the south line of said Lot 13, a distance of 16.73 feet to a point, said point being 54.78 feet right of James Road proposed centerline of construction Station 115+27.93;

Thence across said Lot 12 along the following five (5) describe courses:

- 1. **South 04 degrees 26 minutes 07 seconds West**, a distance of **11.73 feet** to a point, said point being 54.78 feet right of James Road proposed centerline of construction Station 115+16.20;
- 2. **South 76 degrees 10 minutes 46 seconds West**, a distance of **12.58 feet** to a point, said point being 42.83 feet right of James Road proposed centerline of construction Station 115+12.26;
- 3. South 04 degrees 26 minutes 27 seconds West, a distance of 28.43 feet to a point, said point being 42.83 feet right of James Road proposed centerline of construction Station 114+83.83;
- 4. South 76 degrees 20 minutes 11 seconds East, a distance of 12.99 feet to a point, said point being 55.65 feet right of James Road proposed centerline of construction Station 114+81.75;
- 5. South 31 degrees 40 minutes 07 seconds East, a distance of 4.72 feet to the south line of said Lot 12, being the north line of said Lot 11, said point being 58.43 feet right of James Road proposed centerline of construction Station 114+77.93;

Thence North 85 degrees 33 minutes 33 seconds West, along the south line of said Lot 12 and along the north line of said Lot 11, a distance of 20.38 feet to the TRUE POINT OF BEGINNING for the herein described temporary easement.

The above described temporary easement contains a total area of **0.011 acres** located within Franklin County Auditor's parcel number 010-091236.

The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".

Iron pins set are 30" by 5/8" diameter rebar with caps stamped "American Structurepoint PS 8438".
