Thence N 03°10'07" E a distance of 3.00 feet to a point, said point being 45.00 feet left of station 54+04.89;

Thence S 86°49'53" E a distance of 225.11 feet to a point, said point being 45.00 feet left of station 56+30.00;

Thence N 03°10'07" E a distance of 20.00 feet to a point, said point being 65.00 feet left of station 56+30.00;

Thence S 86°49'53" E a distance of 45.00 feet to a point, said point being 65.00 feet left of station 56+75.00;

Thence S 03°10'07" W a distance of 20.00 feet to a point, said point being 45.00 feet left of station 56+75.00:

Thence S 86°49'53" E a distance of 78.89 feet to a point, said point being 45.00 feet left of station 57+53.89;

Thence S 03°10'07" W a distance of 3.00 feet to the point of beginning.

The above described area is contained with the Franklin County Auditor's Parcel Number 610-192340. Within said boundary is 0.045 acres, more or less.

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan "Campus View Boulevard Sidewalk Improvements (3114 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelsville CORS stations were used, which establishes a bearing along the centerline of Campus View Boulevard to be S 86°49'53" E between High Street and Vantage Drive.
