Sir,

The following investigation was conducted concerning the City of Columbus' 2022 annual objection to **91335120634** issued to **UDF Limited Partnership II**, which is doing business as **United Dairy Farmers 634** located at **1680 N. High Street, Columbus, Ohio 43201**. The Division of Liquor Control does not list an individual owner of this permit.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1, C2, and D6** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **forty-one (41)** official police reports concerning incidents at the listed liquor establishment between **January 2021** and **November 2022**. These reports referenced robberies, weapons offenses, molesting, intoxicated persons needing assistance, overdose, assaults, and motor vehicle theft, including:


