




Situated in the State of Ohio, County of Franklin, the City of Columbus, and lying in Virginia Military Survey 422, being a variable width Permanent Storm Sewer Easement lying on, over and across that 1.86 acre tract, as conveyed to Berkheimer Holdings LTD, by deed of record in Instrument Number 200703140044705 (all references refer to the records of the Recorder's Office, Franklin County, Ohio) and more particularly described as follows:

COMMENCING at a point on the southerly right-of-way line of Stimmel Road (40 feet wide) on the easterly line of said 1.86 acre tract and that 3.7 acre tract, as conveyed to Mark A. Powers and Beth A. Powers by deed of record in Instrument Number 201711200164563;

Thence South 12° 57' 33" West a distance of 165.15 feet, coincident with a line common to said 1.86 acre tract and 3.7 acre tract, to the **TRUE POINT OF BEGINNING** for the permanent storm sewer easement herein described:

Thence South 12° 57' 33" West a distance of 40.79 feet, continuing with said coincident line common to 1.86 acre tract and 3.70 acre tract, to a point;

Thence across and through said 1.86 acre tract, the following eleven (11) courses:

Thence North 24° 56' 12" West a distance of 78.11 feet to a point;

Thence North 12° 04' 30" East a distance of 14.28 feet to a point;
