2. **Scope of Work to be performed:** This is a contract for professional engineering design services and services during construction (Design Professional, or "DP" services) for the Jackson Pike Wastewater Treatment Plant Skimmings Concentrator System Improvements. This contract will provide necessary improvements to the existing skimmings concentrator unit and will also provide two new skimmings concentrator unit, skimmings transfer pumps, skimmings grinders, skimmings vault recirculation pumps and associated piping, equipment, and structural modifications. The actual emplacement of the designed work will be by construction contract; this (DP) contract will provide: preliminary design,

detailed design, bidding assistance, construction-phase engineering, start-up and commissioning assistance, record documentatin preparation assistance, and other services for this project, as directed by the City. The construction contract designation is J209.

Engineering Services Progress:

All engineering design services have been completed for this project phase and the construction of this construction contract is ready to proceed.

3. **Schedule to Program completion; "phasing":** The Contract Notice to Proceed was issued March 26, 2003.

The Preliminary Design work for the skimmings concentrator facility was started March, 2003. This investigative and planning effort was summarized in the Detailed Design Memorandum (DDM), submitted to the City on September 14, 2004. In August, 2001, Brown and Caldwell Ohio, LLC proceeded with Detailed Design services for Contract J209. The design was completed and the construction contract bids were received on July 11, 2007. Selection of a contractor is completed, and authorizing legislation for the construction contract is being forwarded for City Council approval simultaneously with the legislation for this contract modification. The construction is required to be completed 12 months after issuance of a Notice To Proceed. Brown and Caldwell Ohio, LLC services will continue beyond completion of construction to provide "as-built" record drawings of the constructed facilities, and also to provide reporting on the status of operation of the constructed facilities one year after completion.
