Situated in the State of Ohio, County of Delaware, City of Columbus, being located in Farm Lot 1, Quarter-Township 3, Township 3 North, Range 18 West, United States Military Lands, and being a part of that 1.001 acre parcel described in a deed to **JCLC ENTERPRISES, LLC**, of record in Official Record 853, page 296, all records referenced herein are on file at the Office of the Recorder for Delaware County, Ohio, being a parcel of land lying on the left side of the proposed centerline of construction for Lazelle Road, as shown on the centerline plat of record in Plat Cabinet ____, Slide ____, and being further bounded and described as follows:

Commencing for reference at Franklin County Monument "FCGS 2226", said point being the southeast corner of said Quarter-Township 3, and being the southeast corner of said Farm Lot 1, said point being at an angle point in the existing centerline of right-of-way for Lazelle Road, said point being on the line between Delaware County and Franklin County, and said point being at Lazelle Road proposed centerline of construction Station 122+83.71;

Thence **North 86 degrees 25 minutes 36 seconds West**, along the south line of said Quarter-Township 3, along said County Line and along the existing centerline of right-of-way for Lazelle Road, a distance of **301.28 feet** to a point, being at the southeast corner of that original 1.7309 acre parcel described in a deed to City of Columbus, of record in Deed Book 552, page 599, said point being at Lazelle Road proposed centerline of construction Station 119+82.44;

Thence **North 03 degrees 34 minutes 25 seconds East**, along the east line of said original 1.7309 acre parcel, a distance of **50.00 feet** to the southwest corner of the grantor's land, being the northwest corner of that 0.368 acre right-of-way parcel described in a deed to City of Columbus, of record in Official Record 200, page 277, (reference an iron pipe found with a "Hockaden & Assoc." cap 0.89 feet east), being on the existing north right-of-way line for Lazelle Road as established by said 0.368 acre parcel, said point being 50.00 feet left of Lazelle Road proposed centerline of construction Station 119+82.44, and said point being the **TRUE POINT OF BEGINNING** for the herein described right-of-way parcel;

Thence **North 03 degrees 34 minutes 25 seconds East**, along the west line of the grantor's land and continuing along the east line of said 1.7309 acre parcel, a distance of **4.00 feet** to an iron pin set, said iron pin set being 54.00 feet left of Lazelle Road proposed centerline of construction Station 119+82.44;

Thence **South 86 degrees 25 minutes 36 seconds East**, across the grantor's land, a distance of **184.59 feet** to an iron pin set on the east line of the grantor's land, being the west line of a 1.066 acre parcel described in a deed to Sancus Retail Partners II LLC, of record in Official Record 866, page 1455, said iron pin set being 54.00 feet left of Lazelle Road proposed centerline of construction Station 121+67.02;

Thence **South 03 degrees 26 minutes 21 seconds West**, along the east line of the grantor's land and along the west line of said 1.066 acre parcel, a distance of **4.00 feet** to a point on the existing north right-of-way line for Lazelle Road, being the southeast corner of the grantor's land, and being the southwest corner of said 1.066 acre parcel, said point being 50.00 feet left of Lazelle Road proposed centerline of construction Station 121+67.03;

Thence **North 86 degrees 25 minutes 36 seconds West**, along the existing north right-of-way line for said Lazelle Road and along the south line of the grantor's land, a distance of **184.59 feet** to the **TRUE POINT OF BEGINNING** for the herein described right-of-way parcel.

The above description contains a total area of **0.017 acres** within Delaware County Auditor's parcel numbers 318-433-01-017-004.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with caps stamped "R/W STRUCTUREPOINT".
