Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southeast corner of said ½ Section 30, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence North 04 degrees 27 minutes 26 seconds East, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 30, a distance of 510.12 feet to an angle point, said point being 9.00 feet left of James Road proposed centerline of construction Station 109+09.33;

Thence North 04 degrees 26 minutes 27 seconds East, continuing along the existing centerline of right-of-way for James Road and continuing along the west line of said ½ Section 30, a distance of 169.75 feet to a point, said point being 8.99 feet left of James Road proposed centerline of construction Station 110+79.08;

Thence North 85 degrees 33 minutes 33 seconds West, along a line perpendicular to the previous course, a distance of 35.00 feet to the intersection of the existing west right-of-way line for said James Road and the existing north right-of-way line for Brownlee Avenue, both established by said East Minster Addition, being the southeast corner of said Lot 353, said point being 43.98 feet left of James Road proposed centerline of construction Station 110+79.08;

Thence North 85 degrees 33 minutes 34 seconds West, along the existing north line of said Brownlee Avenue and along the south line of said Lot 353, a distance of 8.89 feet to an iron pin set on the proposed west right-of-way line for said James Road, said iron pin set being 52.88 feet left of James Road proposed centerline of construction Station 110+79.08, and said iron pin set being the TRUE POINT OF BEGINNING for the herein described temporary easement;

Thence North 08 degrees 07 minutes 16 seconds East, across said Lot 353, a distance of 45.09 feet to a point on the north line of said Lot 353, being the south line of Lot 354 of said East Minster Addition, as said Lot is described in a deed to James J. Gray, of record in Instrument Number 200909180136086, said point being 49.98 feet left of James Road proposed centerline of construction Station 111+24.08;

Thence South 85 degrees 33 minutes 34 seconds East, along the north line of said Lot 353 and along the south line of said Lot 354, a distance of 6.00 feet to a point of the existing west right-of-way line for said James Road, being the northeast corner of said Lot 353, and being the southeast corner of said Lot 354, said point being 43.98 feet left of James Road proposed centerline of construction Station 111+24.08;

Thence South 04 degrees 26 minutes 27 seconds West, along the existing west right-of-way line for said James Road and along the east line of said Lot 353, a distance of 40.52 feet to an iron pin set on the proposed west right-of-way line for said James Road, said iron pin set being 43.98 feet left of James Road proposed centerline of construction Station 110+83.86;

Thence South 67 degrees 43 minutes 11 seconds West, along the proposed west right-of-way line for said James Road and across said Lot 353, a distance of 9.96 feet to the TRUE POINT OF BEGINNING for the herein described temporary easement.

The above described temporary easement contains a total area of **0.007 acres** located within Franklin County Auditor's parcel number 010-090576.

The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".
