

SUBJECT Disposal of Old SCBA Units

Dear Chief O'Connor,

This past year the Division of Fire started a \$4 million project to update and replace our old SCBA units with new, certified SCOTT SCBAs. As a result we have excess equipment that we need to dispose of. Columbus City Code 329.34 requires that personal property of the city that is no longer needed for public use shall be offered to other city agencies or be sold to the highest bidder. We are requesting to bypass this section of the City Code. Michael Halloran, from the City Attorney Office, states that the Safety Director can request the Director of Finance bypass this section and suggests we submit an ordinance permitting us to do so.

Due to the possibility the SCBAs could be used in illegal or other nefarious uses, it would not be appropriate for the Division to offer this equipment for sale to the general public. However, the SCBAs do have some serviceable life to agencies other than the Division of Fire, therefore, we are requesting to dispose of the following equipment by donation to other government agencies:

1. 535 SCBA harnesses
2. 1180 air cylinders
3. 1340 SCBA masks
4. 32 RIT Packs
5. 1260 Voice Amplifiers
6. Miscellaneous parts

If the entire lot is not eliminated by this means, we then request to offer units to Division of Fire members who request their unit as a keepsake. Any remaining units shall be rendered unusable and salvaged with proceeds going into the City General Fund.
