Scope of Work:

- Non-preform all items in **Section 2.1** and associated subsections in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am.
- Complete items 2.2.6, 2.2.7, 2.2.8 and 2.2.9 in **Section 2.2** in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am.
- Complete all items in **Section 2.3** and associated subsections in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am.
- Complete all items in **Section 2.4** and associated subsections in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am.
- Complete all items in **Section 2.5** and associated subsections in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am except for the installation of the pre-terminated fiber optic pig tail. This will be substituted for a run of 288 strand single mode fiber optic cable which will be spliced to 12 - 24 port LC/APC loaded splice cassettes.
- All construction shall comply with the items listed in **Section 1.2 and Section 2.6** and associated subsections in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am.
- All construction shall comply with the requirements listed in the **I-Net's General Specifications Document with Standard Exhibits**.
- Furnish to customer all material in **Section 2.7** and associated subsections in the document titled Fairwood Diverse Route (final) received via email on 6/3/16 @ 9:38 am.
- Furnish and install one (1) 4" riser with two (2) 1 ¼" innerducts and one (1) 2" innerducts at the East Sycamore St Pad Mounted Cabinet location to facilitate placement of the new 288 strand pre-terminated tail if vacant innerduct is not available.

- Gudenkauf Corporation assumes that all work can be performed during normal business hours.
- Pricing does not include sales tax.
- Pricing reflects current prevailing wage rates.
- Pricing does not include any permit or engineering fees.
