## PARCEL 38-T TEMPORARY EASEMENT

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in ½ Section 29, Section 18, Township 12, Range 21, Refugee Lands, and being part of Lot 8 of Easthampton Addition, as recorded in Plat Book 16, page 65, as said Lot is described in a deed to **Steven Lamarr**, of record in Instrument Number 201102180024801, all records referenced herein are on file at the Office of the Recorder for Franklin County, Ohio, being a parcel on the right side of the proposed centerline of construction for James Road, as seen on the centerline plat for James Road, of record in Plat Book \_\_\_\_\_, page \_\_\_\_\_, said parcel being more particularly bounded and described as follows:

Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southwest corner of said ½ Section 29, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence North 04 degrees 27 minutes 26 seconds East, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 29, a distance of 510.12 feet to an angle point, said point being 9.00 feet left of James Road proposed centerline of construction Station 109+09.33;

Thence **North 04 degrees 26 minutes 27 seconds East**, continuing along the existing centerline of right-of-way for James Road and continuing along the west line of said ½ Section 29, a distance of **368.61 feet** to a point, said point being 8.97 feet left of James Road proposed centerline of construction Station 112+77.94;

Thence **South 85 degrees 33 minutes 33 seconds East**, along a line perpendicular to the previous course, a distance of **40.00 feet** to a point on the existing east right-of-way line for said James Road, as established by said Easthampton Addition, being the southwest corner of said Lot 8, and being the northwest corner of Lot 7 of said Easthampton Addition, as said Lot is described in a deed to NGI, LLC, of record in Instrument Number 201402070015759, said point being 31.03 feet right of James Road proposed centerline of construction Station 112+77.93;

Thence **South 85 degrees 33 minutes 33 seconds East**, along the south line of said Lot 8 and along the north line of said Lot 7, a distance of **7.00 feet** to an iron pin set on the proposed east right-of-way line for said James Road, said iron pin set being 38.03 feet right of James Road proposed centerline of construction Station 112+77.93, and said iron pin set being the **TRUE POINT OF BEGINNING** for the herein described temporary easement;

Thence **North 04 degrees 26 minutes 27 seconds East**, along the proposed east right-of-way line for said James Road and across said Lot 8, a distance of **50.00 feet** to and iron pin set on the north line of said Lot 8, being the south line of Lot 9 of said Easthampton Addition, as said Lot is described in a deed to Jerry C. Maxwell, of record in Instrument Number 200205170123924, said iron pin being 38.04 feet right of James Road proposed centerline of construction Station 113+27.93;

Thence South 85 degrees 33 minutes 33 seconds East, along the north line of said Lot 8 and along the south line of said Lot 9, a distance of 19.64 feet to a point, said point being 57.68 feet right of James Road proposed centerline of construction Station 113+27.93;

Thence across said Lot 8 along the following three (3) described courses:

- 1. **South 17 degrees 54 minutes 46 seconds West**, a distance of **11.38 feet** to a point, said point being 55.03 feet right of James Road proposed centerline of construction Station 113+16.87;
- 2. South 34 degrees 45 minutes 04 seconds West, a distance of 23.76 feet to a point, said point being 43.03 feet right of James Road proposed centerline of construction Station 112+96.35;
- 3. **South 18 degrees 50 minutes 34 seconds East**, a distance of **20.05 feet** to a point on the south line of said Lot 8, being the north line of said Lot 7, said point being 50.96 feet right of James Road proposed centerline of construction Station 112+77.93;

Thence North 85 degrees 33 minutes 33 seconds West, along the south line of said Lot 8 and along the north line of said Lot 7, a distance of 12.93 feet to the TRUE POINT OF BEGINNING for the herein described temporary easement.

The above described temporary easement contains a total area of **0.014 acres** located within Franklin County Auditor's parcel number 010-091232.

The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".

Iron pins set are 30" by 5/8" diameter rebar with caps stamped "American Structurepoint PS 8438".
