**PARCEL 140-P
0.0009 ACRE (OR 40.19 SQUARE FEET)
PERMANENT EASEMENT
TO CONSTRUCT A CURB RAMP AND SIDEWALK
WITHOUT LIMITATION OF EXISTING ACCESS RIGHTS
IN THE NAME AND FOR THE USE OF
THE CITY OF COLUMBUS, FRANKLIN COUNTY, OHIO**

An exclusive perpetual easement for public highway and road purposes, including, but not limited to any utility construction, relocation, and/or utility maintenance work deemed appropriate by the City of Columbus, its successors and assigns forever.

Grantor/Owner, for himself and his heirs, executors, administrators, successors and assigns, reserves all existing rights of ingress and egress to and from any residual area (as used herein, the expression "Grantor/Owner" includes plural, and words used in masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1 North, Range 18 West of the United States Military Lands, being part of Lot 9 of Homestead Heights as recorded in Plat Book volume 15, page 7 (all document references are to the records of Franklin County unless otherwise stated), and being a 0.0009 acre parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-075347** as conveyed to **Kayed Nababta** (hereafter referred to as "Grantor") by the instruments filed as **Instrument Numbers 200804040051448** and **199906180155702**.

Being a parcel of land lying on the right side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

COMMENCING FOR REFERENCE at a 1" iron pin set in a monument box on at an angle point in the centerline of right-of-way of Hudson Street, being the southeast corner of Lot 5 of the Partition of Casper Kiner's Heirs as recorded in Deed Book volume 326, page 464, the southwest corner of Highway Park Extension as recorded in Plat Book volume 17, page 354, and being on the northerly line of Grasmere Gardens as recorded in Plat Book volume 15, page 2, said pin being at station 61+45.69 of the said centerline of right-of-way of Hudson Street;

Thence along the said centerline of right-of-way of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 454.71 feet** to a point being at station 66+00.40 of the centerline of right-of-way of Hudson Street;

Thence leaving the centerline of right-of-way of Hudson Street perpendicularly, **South 03 degrees 23 minutes 23 seconds West for a distance of 30.00 feet** to a point at the Grantor's northeast corner, the northeast corner of the said Lot 9, and being at the intersection of the existing southerly right-of-way line of Hudson Street and the westerly right-of-way line of Ontario Street (50' R/W – Public), said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 66+00.40, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the Grantor's easterly line, the easterly line of the said Lot 9, and the said westerly right-of-way line of Ontario Street, **South 03 degrees 23 minutes 34 seconds West for a distance of 4.19 feet** to a point being 34.19 feet right of the centerline of right-of-way of Hudson Street station 66+00.40;

Thence crossing through the lands of the Grantor and through the said Lot 9, **North 74 degrees 18 minutes 34 seconds West for a distance of 19.65 feet** to a point on the Grantor's northerly line, the northerly line of the said Lot 9, and on the said existing southerly right-of-way line of Hudson Street, said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 65+81.19;

Thence along the Grantor's northerly line, the said northerly line of Lot 9, and the said existing southerly right-of-way line of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 19.20 feet** to the **TRUE POINT OF BEGINNING** of the parcel herein described.

The above description contains a total area of **0.0009 acres** (**0.000** acres are located within the Present Road Occupied resulting in a net take of **0.0009 acres**), out of Franklin County Auditor's **Parcel number 010-075347**.

Prior instruments of record as of this writing recorded in **Instrument Numbers 200804040051448** and **199906180155702** in the records of Franklin County.

This description was prepared by Andrew T. Jordan, Ohio Registered Professional Surveyor number 8759, and is based on an actual field survey conducted by American Structurepoint Inc., and is true and correct to the best of my knowledge and belief.

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.

The stations referenced herein are from the plans known as Hudson Street on file with City of Columbus, Ohio having "E" plan number 3575.
