- 3. Simplex is the manufacturer and distributor of our branded fire alarm systems, and JCFP district offices are the <u>ONLY</u> factory trained and certified service providers for the 4007es, 4100, 4010, 4020 series fire alarm systems. Our office in Dublin office has several factory technicians with the latest training and active certifications for Simplex installed fire alarm systems. Our technicians have access to the latest software revisions and product bulletins. It is our belief that Non Simplex certified technicians without licensed software should not perform programming activities on your systems. Further improperly serviced systems can void applicable warranties.

If our technicians happen to encounter problems they cannot resolve on their own, they have numerous ways to get assistance. Some of these include Factory published technical help CDs, FAQ bulletins, factory service and installation manuals, as well as multiple layers of "live" support not only on site but also via telephone directly from the factory. Our service commitment to you is also a commitment from the manufacturer.

If a non-proprietary service provider were to create a <u>major system failure</u> it could not only create a negative financial impact to your facility but could cause your system to be inoperable for an extended period of time. The software is retained in "read only" memory to allow *password-protected* field editing by factory trained, authorized personnel.
- 7. All of your fixed fire protection systems such as sprinkler systems are tied directly into your Simplex Series Fire Alarm Systems

JCFP understands the installed equipment, its design and layout -- allowing most repairs to be completed in hours verses potentially days or weeks if serviced by a non-Simplex entity.
