The consultant has performed the requisite field surveys, geotechnical investigations, and hydraulic calculations necessary to generate the Preliminary Engineering Report which outlined the recommended horizontal and vertical alignments for the proposed sewer. The report concluded that the most economical method for constructing the sewer will be via tunneling methods. Future work shall be that described in #8 below.

The consultant shall perform all necessary geotechnical investigations, field surveys, obtain and prepare all permits necessary, generate detailed construction plans and specifications, prepare site-specific maintenance of traffic plans, and supply all construction documents required for bidding. 9. If the contract modification was not anticipated and explained in the original contract legislation a full explanation as to the reasons the work could not have been anticipated is required. This modification was anticipated and explained in the original contract. The amount of the modification has increased due to rate increases that occurred while the project was on hold, and due to a more thorough understanding of the extent of field investigations required to mitigate the project risks during construction phase.
