## PARCEL 11-S LOCKBOURNE ROAD PERPETUAL EASEMENT TO CONSTRUCT AND MAINTAIN A SEWER IN THE NAME AND FOR THE USE OF THE CITY OF COLUMBUS, FRANKLIN COUNTY, OHIO

A perpetual easement for the construction and maintenance of a sewer in, upon and over the within described real estate. Grantor/Owner herein retains the right to use said real estate for any and all other purposes provided that such use does not interfere with nor impair the exercise of the easement herein granted (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

## [Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Section 27, ½ Section 40, Township 5, Range 22, Refugee Lands, being a strip of land located within that 1.228-acre tract as described in a deed to Ronald and Leann E. Nichols, of record in Instrument No. 200909240138557, Recorder's Office, Franklin County, Ohio, said strip being on the LEFT side of Lockbourne Road (and north of S.R. 104) as delineated upon plans prepared for the City of Columbus and designated as 2746 DR. E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of the southerly line of said 1.228-acre tract with the westerly right-of-way line of Lockbourne Road, said point being located 30.00 feet LEFT of station 32+69.86:

Thence North 86°18'43" West, along said southerly line, a distance of 5.00 feet to a point located 35.00 feet LEFT of station 32+69.85;

Thence North 03°45'55" West, parallel to said right-of-way line, a distance of 30.00 feet to a point located 35.00 feet LEFT of station 32+99.85;

Thence South 86°18'43" East, a distance of 5.00 feet to a point in said westerly right-ofway line located 30.00 feet LEFT of station 32+99.86;

Thence South 03°45'55" West, along said right-of-way line, a distance of 30.00 feet to the place of beginning.

Containing 0.0034 acre, of which the present road occupies 0.0000 acre leaving a net take of 0.0034 acre.

Bearings herein are based on field observations of established control points from the Franklin County Engineers Office, resulting in a bearing of North 03°45'55" East, for the existing centerline of Lockbourne Road between Refugee Road and Marion Road.
