Sir,

The following investigation was conducted concerning the City of Columbus' 2017 annual objection to the renewal of liquor permit **1224450002** issued to **CANDY CANE LLC**, which is doing business as **GLOW LOUNGE** located at **1024 SHADY LANE RD. COLUMBUS, OHIO 43227**. The recorded owner of said permit is **TIANEE STRICKLAND**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **D1, D2, and D3** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations between **January of 2016** and **November of 2017**:

A review of the Columbus Division of Police records revealed the Division of Police have created **(11) eleven** official police reports concerning incidents at the listed liquor establishment **January 2016 and November 2017**. These reports referenced drug offenses, assaults, disorderly conduct, felony thefts, misdemeanor thefts, robbery, and liquor law offenses.

In addition, the Columbus Division of Police has been dispatched to **1024 Shady Lane Rd.** Columbus, Ohio 43227 on **(48) forty eight** separate occasions between **January of 2016 and November of 2017** at **Glow Lounge**.
