Subject: Bikeway Development- General Engineering Design

The Department of Public Service solicited Requests for Proposals for the Bikeway Development- General Engineering Design project. The budget is \$500,000; amount of the contract shall be \$500,000 funded by 2011 bonds.

The intent of this project is to provide the City of Columbus, Division of Mobility Options, additional resources to design and analyze various projects within the Bicentennial Bikeways Plan, as adopted by the City Council on June 2, 2008. These improvements are mostly within the right-of-way, and will consist of projects identified in the Columbus Bicentennial Bikeways Plan such as shared use paths, bike lanes, and shared routes as well as communications and public involvement related to project development. Potential projects include, but are not limited to, Sullivant Avenue Corridor, North Hague Avenue Shared Route and Whitethorne Avenue Bike Boulevard.

The project was formally advertised on the Vendor Services web site from May 24, 2011, to June 23, 2011. The city received eight (8) responses. A proposal from Columbus Engineering Consultants was deemed non-responsive due to not their not meeting all required ODOT pre-qualification categories. Seven proposals were deemed minimally compliant and were fully evaluated when the Evaluation Committee met on July 14, 2011. The responding firms were:
