Situated in the State of Ohio, County of Franklin, City of Columbus, Section 4, Township 1, Range 18, United States Military Lands, and being part of Lot 53 of Hamilton Park No. 4, Plat Book 27, Page 12 of the Franklin County Recorder's Office, and being a part of a 0.19 acre parcel of land on record currently deeded to Dearl E. Alexander and Shirley R. Alexander in Official Record (Instrument No. 201108020095623) of the Franklin County Recorder's Office, and lying on the left side of the centerline of right of way for Jefferson Avenue (50' R/W) as shown on UIRF-South Linden Sidewalks Right of Way Plans, and being more and particularly described as follows:

BEGINNING at the intersection of the East line of Lot 53 with the North line of Lot 53 of Hamilton Park No. 4, Plat Book 27, Page 12 of the Franklin County Recorder's Office, said East line of Lot 53 also being the westerly right of way of Jefferson Avenue (50' R/W), (Station 1+21.42, 25.00 feet left, Jefferson Avenue (50' R/W));

1. Thence **South 03 degrees 37 minutes 26 seconds West** along said westerly right of way of Jefferson Avenue (50' R/W), a distance of **116.42 feet** to a point, (Station 0+05.00, 25.00 feet left, Jefferson Avenue (50' R/W));
2. Thence **North 86 degrees 22 minutes 34 seconds West** along a line through said lot 53, a distance of **10.00 feet** to a point, (Station 0+05.00, 35.00 feet left, Jefferson Avenue (50' R/W));
3. Thence **North 03 degrees 37 minutes 26 seconds East** along a line through said lot 53, a distance of **116.41 feet** to the intersection of said North line of Lot 53 of Hamilton Park No. 4, Plat Book 27, Page 12 of the Franklin County Recorder's Office, (Station 1+21.41, 35.00 feet left, Jefferson Avenue (50' R/W));

4. Thence **South 86 degrees 27 minutes 34 seconds East** along said North line of Lot 53 of Hamilton Park No. 4, Plat Book 27, Page 12 of the Franklin County Recorder's Office, a distance of **10.00 feet** to the POINT OF BEGINNING

The above parcel contains a gross take of 0.027 acres, of which 0.000 acres is present road occupied, leaving a net take of 0.027 acres, more or less, subject to all legal easements and right of ways.

The above described area is part of currently assigned Franklin County Auditor's Parcel Number 010-097738.

The basis of bearing used are relative to the Ohio State Plane Coordinates, South Zone NAD 83 (2011) adjustment, as established by G.P.S. observations by Garcia Surveyors, Inc. The Project Adjustment Factor used for this project is 1.00000000.

Stations and offsets referred to herein are relative to the centerline of right of way of Grasmere Avenue as shown on UIRF-South Linden Right of Way Plans.
