



## DEED OF EASEMENT

KNOW ALL MEN BY THESE PRESENTS that NWD 225 NATIONWIDE, LLC "Grantor", an Ohio limited liability company, for One Dollar (\$1.00) and other good and valuable consideration paid by the CITY OF COLUMBUS, OHIO, "Grantee", a municipal corporation, the receipt of which is hereby acknowledged, does hereby grant to Grantee, its successors and assigns forever, a perpetual easement in, over, under, across and through the following described real property, including the right of reasonable access thereto, for the purposes of constructing, installing, reconstructing, replacing, removing, repairing, maintaining and operating sewer utilities and appurtenances thereto (the "improvement"):

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Section 8, Township 5, Range 22, Refugee Tract, being a 20 foot strip of land across that 1.007 acre tract of land conveyed to NWD 225 Nationwide, LLC of record in Instrument Number 200312260403451 (all references refer to the records of the Recorder's Office, Franklin County, Ohio) being described as follows:

Beginning, for reference, at the southwesterly corner of said 1.007 acre tract;

thence South 89° 06' 55" East, with Grantor's southerly line, a distance of 19.91 feet to the TRUE POINT OF BEGINNING;

thence across Grantor's tract, the following courses and distances:

North 00° 53' 09" East, a distance of 35.67 feet to a point;

South 89° 06' 51" East, a distance of 20.00 feet to a point;

South 00° 53' 09" West, a distance of 35.67 feet to a point in Grantor's southerly line;


