**A description of work performed to date as part of the contract and a full description of work to be performed during any future phasing of the contract.**

This project will provide the Department of Public Utilities the assistance of a qualified and experienced consultant to support the Department in the implementation of its Environmental Management System (EMS). Consultant will be responsible for (1) assisting department staff to ensure that the Department's EMS conforms to the International Organization for Standardization (ISO) 14001:2015 standard, (2) providing air permitting and compliance support, (3) delivering support for Spill Prevention Control and Countermeasures (SPCC) plan updates, and (4) offering other general environmental compliance support as needed.

Services under this agreement are to be provided over a period of three (3) years from date of execution to and including April 16, 2025. Funds for the project shall be reviewed and approved on a year-to-year basis of the three-year contract based upon mutual agreement, availability of budgeted funds and approval Columbus City Council. The recommended award amount for the initial year of this contract is \$165,300.00. If unforeseen issues or difficulties are encountered that would require additional funding, a modification would be requested. This service agreement will not automatically renew.

### Task 1 - EMS Support

Goals in providing EMS support during this next contract cycle are to:

- Support the Environmental Management Representative
  - Augment Reg Com Office staff, as needed
  - Facilitate DPU's conformance with the City's environmental policy
  - Assist DPU with efficiently meeting its obligations, planning for, and managing change, identifying, and correcting non-conformances, and continually improving

- Internal Auditing Support
  - EMS Document Updates
  - Training
  - EMS Outreach
  - Management of Change
  - DPU Staff Supplementation

### Task 2 - Air Permitting and Compliance Support

Over the past three years, the Gresham Smith team's air compliance support services have been focused on streamlining DPU's air program, and in particular, its data management to support permitting decisions, calculating facility potentials to emit (PTE), and annual Title V Fee Emissions Reports (FER).
