JOSEPH E. ANDRY

Past National Commander Disabled American Veterans

Service to his fellow veterans has been the driving force of Joe Andry's life, both in his professional career and in his volunteer involvements. This veteran of the United States Army has achieved many things during the years since 1969 when he lost suffered severe combat wounds in Vietnam. But perhaps his highest honor came in 1990 when his fellow disabled veterans unanimously elected him as National Commander of the 1.2-million-member Disabled American Veterans (DAV).

Born in Cleveland, Mr. Andry was a star athlete at St. Joseph's High School – a member of the 1965 and 1966 State Cross-Country Champions and co-captain of the team in 1966. A premier mile runner, he carried a dream with him when he entered the Army in January 1969. He cherished the thought of competing as an Olympic team distance runner.

That dream came to an abrupt end on August 27, 1969 while Mr. Andry was walking point/flank for his platoon and his company during a movement in a free-fire zone. After a pause, the company moved out, and Mr. Andry felt a tug on his right boot as he tripped a landmine. An enormous explosion left a crater 15 feet wide and six feet deep. The blast took Mr. Andry's left leg and right eye, riddling his body with shrapnel. Yet he says, "It could have been worse." A smoke grenade on his chest stopped a piece of shrapnel that was flying toward his heart. Then, when the smoke grenade went off, it cauterized the stump of his leg, saving him from bleeding to death. A medic and another soldier worked feverishly to hold Mr. Andry's life together until a helicopter arrived, evacuating him to medical treatment. Over the next 32 hours, the young soldier went through several pints of blood as medical teams cleaned his wounds and got him stabilized for a flight to Camp Drake, Japan.

Everything was white when Mr. Andry woke up in Japan. He thought he was heaven, but reality wasn't long in arriving. Before making a phone call to his family in Cleveland, he asked about the extent of his wounds, and the news he received was serious. His upper and lower jaws were broken. His eardrums had burst. An eye had been removed. His right ulna was broken. The muscles in his right forearm had been torn loose. The shrapnel wounds were terrible; particularly severe were the injuries to his right leg. The doctors had amputated what was left of his left leg.

Yes, it was the end of those Olympic aspirations, but Mr. Andry is a man of strong faith and a powerfully positive attitude. That moment of truth, which could have been a tragic crisis and the ruin of another young person's life, marked a turning point. Joe Andry thanked God for the gift of his life, and began a new race to rebuild his life. And the life he built has been a great blessing to thousands of veterans in Ohio and across the United States.

There were many surgeries ahead for this young soldier, and plenty of hard, painful rehabilitation before he was medically retired from the armed forces. At Cleveland State University, Mr. Andry earned two degrees: a bachelor of arts in business and labor relations, as well as a bachelor of science in business education. He attained certification in secondary education in 1975. But the employment market was tough in the 1970s. In a weakened economy, jobs were few and far between. Discrimination against handicapped people, including disabled veterans, was a simple fact of life. And, like many veterans who came home sick and wounded from the Vietnam War, Mr. Andry face an uphill challenge lining up his first job.

He got his first break from the Cleveland Regional Office of the Veterans Administration, predecessor of today's U.S. Department of Veterans Affairs (VA). There, his work as a veterans' benefits counselor marked the beginning of a career devoted to serving other veterans. Today he works in Columbus as Director of the Veterans Services Division, Ohio Bureau of Employment Services.

Mr. Andry has never allowed his commitment to his fellow veterans to end with the close of an eight-hour day. While still in the hospital, he signed up as a life member of the Disabled American Veterans, and he became active in the organization right away. The DAV honored him as its National Outstanding Disabled Veteran of the Year in 1979. While serving as commander of his DAV Chapter, he became active in the DAV's Department of Ohio. Becoming commander of the state DAV organization in 1984-85, he quickly rose through the ranks of the DAV's national organization in the years that followed, being elected National Commander for 1990-91. A life member of DAV Chapter 142 and the DAV's National Amputation Chapter, Mr. Andry remains active in the veterans' movement today. His is a light that cannot be extinguished, a beacon in the lives of his fellow disabled veterans.

Following is a synopsis of Mr. Andry's life, work, and extensive involvement in the world of veterans' affairs.

MILITARY SERVICE

1969 - 1970 U.S. Army

- Advanced Individual Training (AIT), Fort Polk, Louisiana. Was acting platoon sergeant and supervised 90 men. Spent four months in Vietnam as point/flank man for his platoon and company.
- Wounded in action in Vietnam, sustained left leg amputation to the hip, removal of right eye and other conditions. Honorably discharged for medical reasons.
- Decorations and awards include the Purple Heart, Combat Infantry Badge, Air Medal, National Defense Ribbon w/ Device, Vietnam Service Medal, and Republic of Vietnam Campaign Ribbon w/ Device

EDUCATION

- Cleveland State University, Cleveland, Ohio. Bachelor of Science in Business Education, Certified in Secondary Education. Bachelor of Business Administration.
- A large number of professional and technical training programs.

PROFESSIONAL & LEADERSHIP CAREER

1994 - Present Director of Veterans Services Division, Ohio Bureau of Employment Services, Columbus, Ohio

- Directs entire operations of assigned division/program area on a statewide basis, implements assigned program and ensures compliance with applicable state & federal laws & agency rules, regulations, policies & procedures and supervises assigned staff.
- Develops and implements program changes to meet current needs and/or changes in state and federal law. Assists in drafting legislation related to veterans issues and programs. Outlines/defines goals, objectives and performance standards. Determines staffing needs and identifies staff from operating and support divisions that will be utilized during particular phases of projects/programs.
- Represents agency at meetings/seminars. Administers record keeping and reporting
 systems. Investigates and resolves internal and external complaints and/or grievances.
 Manages administrative budget for division. Authorizes payment of invoices.
 Prepares program reports and operates computer terminal to enter, retrieve, edit or
 verify data.

Accomplishments:

- Established Ohio Transitional Assistance Program (OTAP) for all veterans and their spouses. Since 1993, 6,900 veterans/spouses have completed the program with 3,800 placed within 90 days after completion of the OTAP.
- Participated in U.S.DOL-VETS case management pilot program, which led to new nationwide policies and procedures to help eliminate employment barriers for veterans.

- Established "Hire A Veteran Month" with employer recognition events and job & information fairs held throughout Ohio. Veteran placements have increased each year.
- Initiated the Veterans Employment Representative on Campus (VEROC)
 Program to assist 3,000 disabled veterans in VA training with supportive services and employment during and after training. This program has been nominated for the Vice President's Hammer Award and the VA's Scissors Award for reinvention.
- Established and coordinates "Operation Coming Home." Letters are sent all
 over the world to separating military personnel signed by the Governor and
 OBES Administrator. In addition, Labor Market Information and informational
 pamphlets are provided. Approximately 12,000 to 15,000 military personnel
 return to Ohio each year.
- OBES is one of eight states participating in a veterans alternative performance measures pilot program.
- OBES is one of five states participating in a pilot licensing/certification program for soon-to-be and recently separated veterans.

1988 - 1994 Executive Director, Adjutant and Treasurer, Disabled American Veterans, Department of Ohio

- Responsible for administrating and overseeing 128 chapters, 60,000 members, and an annual Department budget of up to \$750,000. Provided chapters ongoing technical assistance to conform to national organization bylaws and state and federal laws.
- Responsible for the planning and execution of the Annual Fall Conference and Annual State Convention, and other meetings throughout the year, *i.e.*, hotel, agenda speakers, receptions, etc.
