Grantor/Owner, for himself and his heirs, executors, administrators, successors and assigns, reserves all existing rights of ingress and egress to and from any residual area (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 52 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "OHIO ACHIEVEMENT CHARTER SCHOOLS, INC., AN OHIO NON-PROFIT CORPORATION, D/B/A THE MILLENNIUM COMMUNITY SCHOOL" (hereafter referred to as Grantor) as described in Instrument No. 201609220128505 of the Franklin County Recorder's Office and being more particularly described as follows:

COMMENCING at a **1" Rebar Set** at the intersection of the existing centerlines of right-of-way of Refugee Road (width varies) and Schwartz Road (60 foot right-of-way) on the existing centerline of right-of-way of Refugee Road at station 28+89.33, also on the existing centerline of right-of-way of Schwartz Road at station 50+00.00;

THENCE with the existing centerline of right-of-way of Refugee Road, **South 85 deg. 43 min. 08 sec. East** for a distance of **707.94 feet** on the existing centerline of right-of-way of Refugee Road at station 35+97.27;

THENCE, perpendicular with said centerline, **North 04 deg. 16 min. 52 sec. East** for a distance of **60.00 feet** to the north line of a 0.9401 acre tract designated as Parcel No. 13 as appropriated by the City of Columbus in Franklin County Court of Common Pleas Case No. 231507 as recorded in Deed Book 3017, page 301 in the North right-of-way line of Refugee Road, the

Grantor' Southwest corner, and the Southeast corner of lands conveyed to the First Church of God, Inc., a non-profit Ohio corporation as described in Instrument No. 199802230039216 at 60.00 feet left of the existing centerline of right-of-way of Refugee Road station 35+97.27, being witnessed by an iron pin found North 41 deg. 30 min. 45 sec. East, 0.33 feet, and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE with the Grantor's West line and the East line of First Church's lands, **North 04 deg. 16 min. 52 sec. East** for a distance of **10.00 feet** to an **Iron Pin Set** at 70.00 feet left of the existing centerline of right-of-way of Refugee Road at station 35+97.27;

THENCE through the Grantor's lands, **South 85 deg. 43 min. 08 sec. East** for a distance of **169.98 feet** to an **Iron Pin Set** on the Grantor's East line and the northerly right-of-way line of Refugee Road as dedicated in Plat Book 45 page 118 at 70.00 feet left of the existing centerline of Right-of-way of Refugee Road at station 37+67.25;

THENCE with the Grantor's East line the northerly right-of-way line of Refugee Road, **South 04 deg. 12 min. 21 sec. West** for a distance of **10.00 feet** to the Northeast corner of said Parcel No. 13 in the northerly existing right-of-way line of Refugee Road at 60.00 feet left of the existing centerline of Right-of-way of Refugee Road at station 37+67.26, being witnessed by an iron pin found North 38 deg. 05 min. 37 sec. East, 0.33 feet;

THENCE continuing with the North line of said Parcel No. 13 with the northerly existing right-of-way line of Refugee Road and the Grantor's South line, **North 85 deg. 43 min. 08 sec. West** for a distance of **169.99 feet BACK TO THE TRUE POINT OF BEGINNING**.

The above-described parcel contains 0.039 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-288330.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

All Iron Pins described as set are 5/8" x 30" rebar with a with a yellow plastic cap stamped "R/W Burgess & Niple" and shall be placed upon notification from the City of Columbus at the completion of construction.
