

**PARCEL 10-T1**  
**TEMPORARY CONSTRUCTION EASEMENT**  
**0.032 ACRE TRACT (1377.2 S.F.)**  
**EXHIBIT "A"**

Situated in the State of Ohio, County of Franklin, City of Columbus, Virginia Military Survey No. 1425 and being part of Lot 1 of Countrybrook Subdivision Tract I as recorded in Plat Book 41, Page 116 and re-recorded in Plat Book 49, Page 18 as conveyed to Ashton Square Associates, LP as described in Instrument Number 200206280159722, all references being those of record in the Franklin County, Ohio Recorder's Office, and being more particularly described as follows:

Beginning in the southerly existing right of way line of Sullivant Avenue West (RW Varies) and the easterly right-of-way line of Countrybrook Drive East (60') and being 45.86 feet right of centerline of right of way of Sullivant Avenue West station 207+36.21;

Thence easterly, along the said southerly right of way line of Sullivant Avenue West, South 77°03'31" East, 206.79 feet to a point being 45.41 feet right of centerline of right of way of Sullivant Avenue West station 209+43.00;

Thence southerly, South 13°03'56" West, 6.59 feet to a point being 52.00 feet right of centerline of right of way of Sullivant Avenue West station 209+43.00;

Thence westerly, crossing the said property, North 76°55'56" West, 221.16 feet to the said easterly right-of-way line of Countrybrook Drive East and being 52.00 feet right of centerline of right of way of Sullivant Avenue West station 207+21.84;

Thence northeasterly, along the said easterly existing right-of-way line of Countrybrook Drive East with a curve to the right, having a radius of 20.00 feet, an arc length of 16.06 feet, an internal angle of 45°59'51", and a chord that bears North 79°56'34" East a distance of 15.63 feet to the Point of Beginning, containing 0.032 acres (1377.2 S.F.), more or less.

Subject to all legal rights-of-way and/or easements, if any, of previous record.

The bearings on this plan are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (2011). Said bearings originated from a field traverse which was referenced to the said coordinate system by GPS observations and observations of selected stations in the Ohio Department of Transportation Virtual Reference Station Network. The portion of the centerline of Sullivant Avenue West, having a bearing of South 76°55'56" East, is designated the "Basis of Bearing" for this description.
