Situated in the State of Ohio, County of Franklin, City of Columbus located in Quarter Township 2, Township 2, Range 18 (USML) and being a part of a 3.013 acre tract of land conveyed to Shanghi Enterprises, LLC by deed of record in I.N. 201012160171082 of the Recorders office, Franklin County, Ohio and being more particularly described as follows:

Beginning at a point, said point being 34.85 feet left of station 26+60.35, said point being the point of beginning;

Thence in a westerly direction with a curve to the left with a radius of 32.50 feet, having a chord bearing of N 87°31'29" W and a chord distance of 26.52 feet, having a central angle of 48°09'47" and an arc length of 27.32 feet to a point, said point being 50.00 feet left of station 26+79.52;

Thence in a northwesterly direction with a curve to the right with a radius of 361.68 feet, having a chord bearing of N 45°51'03" W and a chord distance of 64.30 feet, having a central angle of 10°11'57" and an arc length of 64.38 feet to a point, said point being 50.00 feet left of station 27+35.01;

Thence N 42°26'19" E a distance of 15.11 feet to a point, said point being 35.00 feet left of station 27+36.62;

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan "Campus View Boulevard Sidewalk Improvements (3114 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelsville CORS stations were used, which establishes a bearing along the centerline of Campus View Boulevard to be S 86°49'53" E between High Street and Vantage Drive.
