COMMENCING at an 8 inch mag nail set at the intersection of Right of Way lines of Edsel Avenue (50' R/W) and Koebel Road (60' R/W), being the grantor's southwest corner and being the most southeastern corner of Edsel Ave. as dedicated in Walnut Springs in Plat Book 33, page 74, Thence along the east existing Right of Way line for Edsel Ave., North 4 degrees 44 minutes 50 seconds East, 10.08 feet to an iron pin set, said iron pin set being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, across the grantor's tract, with a curve to the left having a radius of 10.00, a central angle of 90 degrees 28 minutes 00 seconds, an arc length of 15.79 feet and a chord that bears, **South 40 degrees 29 minutes 10 seconds East, 14.20 feet** to an iron pin set on the grantor's south line and the north existing Right of Way for Koebel Road;
- 2) **Thence**, along the grantor's south line and the north existing Right of Way for Koebel Road, **North 85 degrees 43 minutes 10 seconds West, 10.08 feet** to a point at the intersection of Right of Way lines of Edsel Avenue (50' R/W) and Koebel Road (60' R/W), being the grantor's southwest corner and being the most southeastern corner of Edsel Ave.;
