[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus in the Section 1 of Township 1, Range 18, United States Military Lands, being a part of Lot 69 of Oakland North Broadway as recorded in Plat Book 4, Page 370 of the Franklin County Recorder's Office, also known as being a part of the property conveyed to Daniel R. O'Neil and Margaret R. O'Neil by Official Record 8891J10, of the Franklin County Recorder's Office, (Franklin County Auditor's Parcel Number 010-067198-00), being Parcel 32-T on the right side of the existing centerline of Right-of-Way of Indianola Avenue (Right-of-Way 58') as shown on the City of Columbus Right-of-Way Plans for Indianola Avenue (1908-A) and being more particularly described as follows:

Beginning at a point at the southwest corner of said O'Neil property, said point being in the existing easterly Right-of-Way line of said Indianola Avenue by Deed Book 918, Page 323, said point also being 30.00 feet right of Station 156+80.47 of said centerline of Right-of-Way of Indianola Avenue and the **True Point of Beginning** for the parcel herein described;

Thence, along the common line of said O'Neil property and easterly Right-of-Way line, **North 04 degrees 11 minutes 20 seconds East, 48.00 feet** to the northwest corner of said O'Neil property, said point being 30.00 feet right of Station 157+28.47 of said centerline of Right-of-Way of Indianola Avenue;

Thence, along the northerly line of said O'Neil property, **South 86 degrees 06 minutes 48 seconds East, 1.50 feet** to a point, said point being 31.50 feet right of Station 157+28.48 of said centerline of Right-of-Way of Indianola Avenue;

Thence, across said O'Neil property, **South 04 degrees 11 minutes 20 seconds West, 48.00 feet** to a point in the southerly line of said O'Neil property, said point being 31.50 feet right of Station 156+80.48 of said centerline of Right-of-Way of Indianola Avenue;

Thence, along the southerly line of said O'Neil property, **North 86 degrees 07 minutes 05 seconds West, 1.50 feet to the Point of Beginning**, containing 0.002 acre (72.0 sq. ft) more or less, all of which is in Franklin County Auditor's Parcel Number 010-067198-00.

Subject to all, legal, easements, rights-of-way, conditions and restrictions.
