

Description of a 0.449 Acre Permanent Storm Sewer Easement Parcel 18-P

Situated in the State of Ohio, County of Franklin, the City of Columbus, and lying in Virginia Military Survey 422, and being a variable width Permanent Storm Sewer Easement lying on, over and across that 27.91 acre tract, as conveyed to Bishop Edward J. Herrmann, by deed of record in Volume 8, Page 10 (All references refer to the records of the Recorder's Office, Franklin County, Ohio) being more particularly describe as follows:

COMMENCING at the intersection of the line common to the westerly line of said 27.91 acre tract and the southerly right-of-way line of W. Mound Street (66 feet wide);

Thence North 70° 49' 45" East a distance of 80.56 feet, coincident with said southerly right-of-way line of West Mound Street, to a point being the **TRUE POINT OF BEGINNING** for the permanent storm sewer easement herein described:

Thence North 70° 49' 45" East a distance of 20.90 feet, coincident with said southerly right-of-way line of West Mound Street, to a point;

Thence across and through said 27.91 acre tract the following eight (8) courses:

South 36° 02' 46" East a distance of 403.68 feet, to a point;

South 35° 22' 44" East a distance of 41.55 feet, to a point;

South 34° 19' 39" East a distance of 57.16 feet, to a point;

South 36° 01' 02" East a distance of 49.43 feet, to a point;

South 36° 10' 45" East a distance of 228.35 feet, to a point;

COMMENCING at the intersection of the line common to said westerly line of said 27.91 acre tract and the existing southerly right-of-way line of West Mound Street (66 feet wide);

Thence North 70° 49' 45" East a distance of 101.46 feet, being coincident with said southerly right-of-way line of West Mound Street;
