## BACKGROUND:

- The requested Council variance will allow for reduced development standards.
   Variances for landscaping and screening, parking setback line, and building setback line are included in this request.
- A Council variance is required because the pending L-M, Limited Manufacturing District does not allow the reductions of the proposed development standards.
- North of the site is a manufacturing facility in the M, Manufacturing District. South of the site is an undeveloped parcel in the AR-12, Apartment Residential District. East of the site is a bus storage facility in the C-4, Commercial District. West of the site are singleunit dwellings in the C-4, Commercial District.
- The Applicant has received a recommendation of approval from Staff and from the Development Commission for a concurrent rezoning request (Z24-031) to the L-M, Limited Manufacturing District.
- The site is within the planning boundaries of the *North Central Plan* (2002), which recommends "Open Space" land uses at this location.
- The site is located within the boundaries of the North Central Area Commission whose recommendation is for approval.
- Staff concurs with the applicant's analysis of the seven practical difficulties in achieving this proposed development.

### CITY DEPARTMENTS' RECOMMENDATION: Approval

Staff recognize new plantings and landscaping along Brentnell Avenue as a mitigating factor for support of the requested variances.

#### STATEMENT OF HARDSHIP

#### Columbus City Code Section 3307.10 - Variances by City Council.

City council may grant the following zoning variances:

- A. Permit a variation in the yard, height or parking requirements of any district only in conjunction with a change in zoning or a use variance and only where there are unusual and practical difficulties in the carrying out of the zoning district provisions due to an irregular shape of lot, topography, or other conditions, providing such variance will not seriously affect any adjoining property or the general welfare.
- **B.** Permit a use of the property not permitted by the zoning district established on the property if such use will not adversely affect the surrounding property or surrounding neighborhood and if council is satisfied that the granting of such variance will alleviate some hardship or difficulty which warrants a variance from the comprehensive plan.

Before authorizing any variance from the Zoning Code in a specific case, city council shall first determine that such variance will not impair an adequate supply of light and air to the adjacent property, unreasonably increase the congestion of public streets, increase the danger of fires, endanger the public safety, unreasonably diminish or impair established property values within the surrounding area, or in any other respect impair the public health, safety, comfort, morals or welfare of the inhabitants of the city.

In granting a variance pursuant to this section, council may impose such requirements and conditions regarding the location, character, duration, and other features of the variance proposal as council deems necessary to carry out the intent and purpose of this Zoning Code and to otherwise safeguard the public safety and welfare.

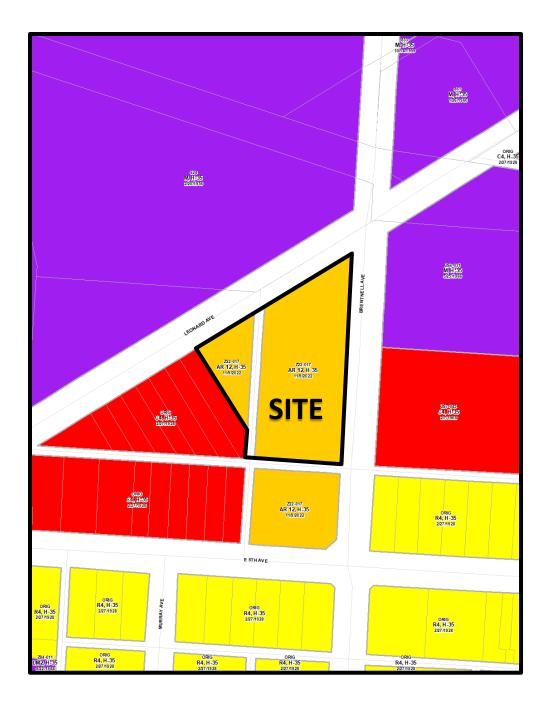

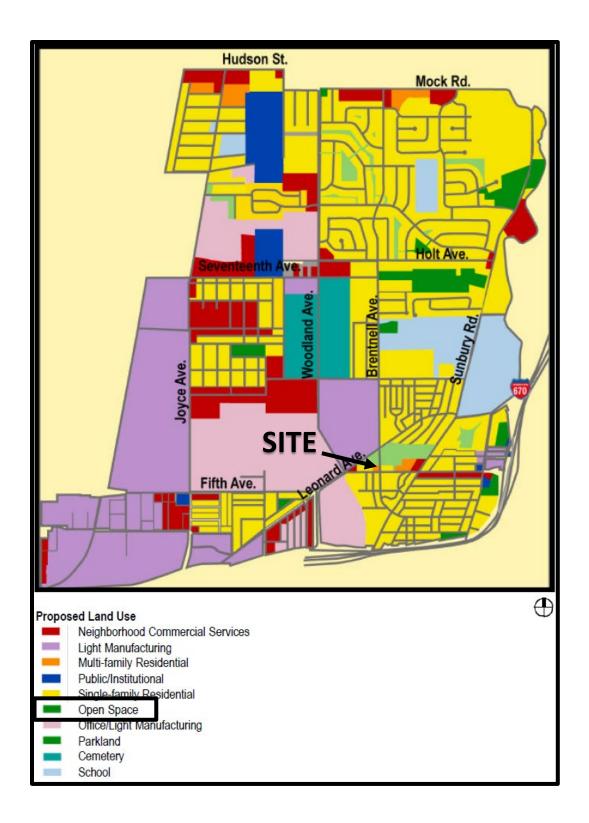
