Bids for 100' aerial platform ladders were received by the Purchasing Office on February 4, 2010. At the request of the Public Safety Director, a committee of representatives from the Fire Division, Purchasing Office, and the Fleet Management Division, convened to review the bids on April 21, 2010. On May 17, 2010, the committee recommended to the Public Safety Director the bid from Sutphen Corporation as "the overall most compliant bid, lowest price, and vehicle that is best for [Fire's] overall need."

The Public Safety Department supports the recommendation of the committee in selecting Sutphen Corporation as the lowest and overall best bid and has authored legislation in the total amount of \$2,988,475.20 to procure three 100'aerial platform ladders. The total bid amount is based upon a price of \$996,158.40 per unit. A breakdown of the bids and unit pricing is attached for your review.

Sutphen Corporation submitted the lowest bid price of the four bids received, and the vehicle that is best for the Fire Division's overall need. However, due to a number of detailed and inflexible bid specifications, several of the vendors, including Sutphen, either submitted alternate equipment or listed exceptions for some of the bid items. Therefore, the Public Safety Department recommends a waiver of the competitive bid requirements.
