[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, Township of Blendon, being located in Quarter Township 4, Township 2, Range 17 of the United States Military Lands and being 0.034 acres within a 0.588 acre parcel conveyed to KATIE R HIXON, TR & GARY L BONECUTTER, TR, as described in Instrument Number 200110180240017 and being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning at an iron pin set on the westerly existing right-of-way of Hamilton Road, said point being 60.00 feet left of centerline Station 97+08.76;

Thence along the existing southerly property line of said 0.588 acre tract, North 85°46'11" West, a distance of 5.00 feet to a point on the existing southerly property line, being 65.00 feet left of centerline Station 97+08.84;

Thence across the said 0.588 acre tract, North 3°19'21" East a distance of 51.16 feet to a point being 65.00 feet left of centerline Station 97+60.00;

Thence across the said 0.588 acre tract, North 86°40'39" West a distance of 23.00 feet to a point being 88.00 feet left of centerline Station 97+60.00;

Thence across the said 0.588 acre tract, North 3°19'21" East a distance of 40.00 feet to a point being 88.00 feet left of centerline Station 98+00.00;

Thence across the said 0.588 acre tract, South 86°40'39" East a distance of 21.00 feet to a point being 67.00 feet left of centerline Station 98+00.00;

Thence across the said 0.588 acre tract, North 3°19'21" East a distance of 17.04 feet to a point on the northerly property line of said 0.588 acre tract, being 67.00 feet left of centerline Station 98+17.04;

Thence along the northerly property line of said 0.588 acre tract, South 85°48'39" East a distance of 7.00 feet to an iron pin set on the westerly right-of-way line of Hamilton Road, being 60.00 feet left of centerline Station 98+16.94;

Thence along the proposed westerly right-of-way line of Hamilton Road, South 3°19'21" West a distance of 108.18 feet to the point of beginning, containing 0.034 acres, more or less.

The above described area is within Auditors Permanent Parcel Number 112-000047.


