This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Resurfacing – Resurfacing 2011 Zone 2 project.

### Project Scope:

- Part A Resurfacing and Part B ADA Curb Ramps (1674 Dr. A): Repairs and resurfaces thirty-four (30) city streets and constructs 394 ADA curb ramps along those streets. The work consists of milling the existing pavement, overlaying with new asphalt concrete, minor curb replacement, and replacing curb and sidewalk associated with installing ADA wheelchair ramps. Where warranted, the plans also call for areas of full depth pavement repair.
- Part C Intersection Improvements Olentangy River Road at Henderson Road (2811 Dr. E): Constructs a right turn lane from Olentangy River Road (South Bound) onto west Henderson Road (West Bound) and new curbs and curb ramps.

Fiscal Impact: Source of funds is 2010 bonds fund

<u>Schedule:</u> Bids were opened February 25, 2011; estimated Council date is April, 2011; estimated NTP date is April 25, 2011. The contract length is 135 days from the date of the Notice to Proceed.

Engineer's Estimate: \$5,927,945.48
