Sir,

The following investigation was conducted concerning the City of Columbus' 2022 annual objection to the renewal of liquor permit **84189940430** issued to **Speedway LLC**, which is doing business as **Speedway #1216** located at **6175 E. Livingston Avenue, Columbus, Ohio 43232**. The Division of Liquor Control does not list an individual owner of this permit.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1, C2, and D6** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **thirty-five (35)** official police reports concerning incidents at the listed liquor establishment between **January 2021** and **November 2022**. These reports referenced a shooting, robbery, menacing, discharging firearms, weapons offenses, intoxicated persons needing assistance, assault, kidnapping, and motor vehicle theft, including:



In addition, the Columbus Division of Police and Division of Fire have been dispatched to **6175 E. Livingston Avenue, Columbus, Ohio 43232** on **three hundred seventy-four (374)** calls for service, **two hundred twenty-three (223)** in 2021, and **one hundred fifty-one (151)** in 2022 at **Speedway**. These calls for service include responses to shootings, robberies, shots fired, persons with a gun, person with a knife, prostitution, sex crimes, OVI, intoxicated persons needing assistance, overdoses, assaults, fights, disturbances, domestic violence, persons with outstanding warrants, disturbances, and motor vehicle thefts.
