The undersigned do hereby respectfully petition to authorize Downtown Central Special Improvement District of Columbus, Inc. (the "District") and to approve a Levy and Plan for Services (the "Plan") pursuant to Chapter 1710 of the Ohio Revised Code. The boundaries of the District, services under the Plan, and area within which the Plan will be executed are described and shown in the attached Exhibit. Each of the undersigned is the owner, or the authorized signatory of the owner, of the property or properties set forth below, which comprise 60% or more of the front footage of property abutting upon the streets, alleys, public roads, places, boulevards, parkways, park entrances, easements and other public improvements situated in the District.

The undersigned acknowledge that the approval of this petition will permit the following:

- (1) The levy of an annual assessment of \$2,715,133 on properties within the District boundaries, beginning January 1, 2027, and running five years through December 31, 2031;
- (2) The exercise of discretion by trustees of the District on how to allocate funds among the services set forth in the Plan;
- (3) The cost of the Plan to be \$2,815,133 in 2027, including contributions of \$250,000 from the City of Columbus and \$100,000 from the Central Ohio Transit Authority, and that these contributions by the City of Columbus and Central Ohio Transit Authority are necessary to deliver an adequate level of services on High Street and other major thoroughfares.
- (4) The board of trustees for the District to have the option of terminating the SID Plan if the City of Columbus or COTA do not make an annual contribution of at least \$250,000 and \$100,000, respectively.

Summary of Plan

The Downtown Central Special Improvement District of Columbus, Inc. (“District”) proposes a Plan for Services (“Plan”), to commence January 1, 2027, and expire after December 31, 2031. The Plan will provide for environmental maintenance, maintenance of capital improvements and landscaping, supplemental security, and homelessness engagement services at an initial annual cost of \$2,715,133 for service year 2027, with no increases over the five-year plan, plus unrestricted contributions from exempt property owners.

The Plan will be funded by an annual special assessment on property within the District in the annual amount of \$2,715,133 for each service year beginning in 2027, (in aggregate, the “Assessment,” and in any portion, the “Assessments”), plus unrestricted contributions from exempt property owners.

Background

In response to growing concern about conditions in the core area of downtown Columbus, Capitol South, the City of Columbus, Ohio (“Columbus”) and the Greater Columbus Chamber of Commerce surveyed area property owners in 1999 to gauge their interest in funding a management district for the area. Owners expressed an interest in creating a special improvement district (“SID”) to fund a variety of services.

A SID is a self-help tool, governed by Chapter 1710 of the Ohio Revised Code, allowing property owners within a self-defined district to organize and assess themselves the cost of providing area-wide services. If owners representing 60% of the front feet along public streets and alleys within a district agree to create a SID and provide services, then all owners within the district are required to contribute their fair share of the cost.

Property owners in a 25-square block area of downtown petitioned Columbus City Council in July, 2000, to create a SID and, later that month, incorporated the Capital Crossroads Special Improvement District (“CCSID”). Since January 2002, the CCSID executed five plans for services, with the last scheduled to end on December 31, 2025. Due to this end of services, interested property owners seek to create a new SID and seek approval of the Plan for Services described in this document to begin on January 1, 2027 and continue through December 31, 2031.

Plan for Services

The District intends to deliver the following services, as determined from time to time by the District Board of Trustees (“District Board”):

Environmental Maintenance

Services that make the District cleaner and control litter on publicly-owned sidewalks and publicly-owned connecting pedestrian spaces, including High Street pocket parks at intersecting alleys and dedicated pedestrian alleys; for example:

- Washing and power washing of sidewalks and other pedestrian rights of way;
- Washing and power washing of public telephones, benches, trash containers, and other fixtures in pedestrian rights of way;
- Removal of weeds and litter;
- Sidewalk sweeping;
- Sweeping and washing of pedestrian rights of way, as needed, to remove vomit, urine, beverage spills, and other organic materials;
- Graffiti removal from fixtures in pedestrian rights of way;
- Graffiti removal from the pedestrian level of building facades that front public streets and alleys;
- Limited snow and ice removal in areas that are not the responsibility of property owners or Columbus, for example, crosswalks at street curbs and storm sewer openings and grates;
- Systems to report and correct the failure of public and private entities to deliver services or maintain property, including Columbus, private property owners, private trash collectors, and other service providers.

Maintenance of Capital Improvements and Landscaping

Services that improve the appearance of the District, for example:

- Required landscaping and maintenance of capital improvements completed under the District's 2009 Downtown Public Realm Enhancement Plan;
- Required landscaping and maintenance of Gay Street improvements;
- Pole-mounted flowers on pedestrian street lights;
- Trash containers;
- Maintenance of other public space, including dog parks and pocket parks.

Supplemental Security

Services that make the District safer and improve perceptions of safety; for example:

- Coordination of all safety services through the Safer Downtown Command Center
- Radio-equipped and uniformed foot and bicycle patrols; Community "ambassador" services for the general public, including directions, assistance, general information, and hospitality;
- Surveillance to assist in the intervention and prevention of crime;
- Efforts to reduce panhandling, public consumption of alcohol, inebriates, and intimidating behavior;
- Deployment of a uniformed presence to improve perception of safety;
- Crime advisories;
- Crime prevention advice, literature, and programs;
- Communication services among street-level commercial tenants.
- Data and information sharing across safety partners.

Homeless Engagement and Coordination Activities

Services that provide thoughtful engagement with people experiencing homelessness or are in crisis in public areas; for example:

- Homeless outreach specialists and outreach training for cleaning and safety ambassadors;
- Court advocates working with social service agencies and court partners to determine and advocate for meaningful sentencing of repeat offenders to reduce recidivism;
- Coordination with the City of Columbus and social service agencies focused on these

types of services.

District Management

The SID will contract with Safer Downtown, LLC, an Ohio limited liability company (“Safer Downtown”), for the necessary administrative services and coordination. Safer Downtown will have dedicated staff to work on fulfilling the contract with the SID.

Budget

The initial cost of the Plan will be \$2,715,133 for all service years beginning in 2027. The District Board will be given discretion on how to allocate funds among the services to be provided. The District Board will produce an annual report for members of the District, describing how funds are allocated. The District Board will survey members annually to secure broad input about how to allocate funds.

Area to Be Served

Unless otherwise directed by the District Board, services for properties that are exempt from the Assessment under Chapter 1710 of the Ohio Revised Code will be provided only if such properties have requested inclusion in the District or have committed to voluntary payments, in lieu of being included in the District, for each service to be provided. Other properties outside the District may contract with the District to provide services, provided that the contract price covers the full cost of providing such services.

The Plan will be executed within the area described in the attached Exhibit A and shown in the map in the attached Exhibit B.

Method of Assessment

Pursuant to Ohio Revised Code Section 1710.06, each member’s share of the cost of the Plan and of the Assessment will be in proportion to the benefits which may result from the Plan.

The determination of each member’s proportionate share of the cost of the Plan and of the Assessments, for each calendar year of the Plan, shall be made as of May 1 of the preceding calendar year. The value of real property and improvements of each tax parcel shall be based on the values then shown on the records of the Franklin County Auditor. The front feet of each tax parcel and the gross floor area of building improvements situated on each tax parcel shown on the records of the Franklin County Auditor shall be presumed to be accurate, unless and until rebutted by more accurate information.

The total initial annual Assessment shall be \$2,715,133 for service year 2027 and will not be increased for any service year during which the Plan is in effect, to be assessed against the benefited parcels according to the following formula, which is in proportion to the benefits resulting from the Plan:

1) Base Formula

- a) 50% will be assessed against the property within the District according to the value of real property and improvements of each tax parcel as determined by the Franklin County Auditor.
- b) 50% will be assessed against the property within the District according to the front feet of each tax parcel on public streets and alleys that are more than 30 feet in width.

2) Assessment Limits

- a) With respect to a tax parcel, the principal use of which is other than parking or a public park, the members' proportionate share of the cost of the Plan and of the Assessment for the gross floor area of building improvements situated on such tax parcel will not be less than 9.43 cents per square foot, or more than 15.75 cents per square foot for service years 2027-31.
- b) No property owner shall be assessed more than \$264,440.00 for service years 2027-31 under this Plan. If a property owner subject to the capped amount stated above purchases additional property within the District, the cap shall not apply to the additional property.
- c) Whenever any building improvement is situated on two or more adjacent tax parcels under common ownership, then the member's proportionate share of the cost of the Plan and of the Assessment will be computed first by combining such tax parcels. Costs will then be allocated among such tax parcels in proportion to the aggregate value of real property and improvements of the respective tax parcels as determined by the Franklin County Auditor. If such a building improvement is a condominium, costs will be allocated among such tax parcels in proportion to each unit's par value relative to the aggregate par value of all parcels as provided in the condominium declaration on file with the Franklin County Recorder.

3) Boundary Changes

- a) If the District boundaries expand beyond the proposed boundaries within this Plan, the total annual Assessment shall increase to an amount equal to the then-current total annual Assessment plus Assessments generated by additional parcels. Additional Assessments shall be calculated using the formula above.
- b) If the District boundaries contract from the proposed boundary within this Plan, the total annual Assessment shall decrease to an amount equal to the then-current total annual Assessment less the amount of Assessments that would have generated by properties excluded by the new boundaries using the formula above.

Term of Assessment and Services Plan

Assessments will begin to accrue on July 1, 2026, and will terminate after June 30, 2031. Services to be provided by the Plan will begin on January 1, 2027. Services provided by the Plan will terminate after December 31, 2031.

The District Board will have the option of terminating all or a portion of the Plan prior to December

31, 2031 if the City of Columbus does not make an annual contribution of at least \$250,000 or COTA does not make an annual contribution of \$100,000 respectively. These contributions will be made directly to Safer Downtown, Inc. or an affiliate thereof. If the District Board determines to terminate all or a portion of the Plan prior to December 31, 2031, the annual Assessment shall be adjusted downward such that annual Assessments shall be levied in amounts sufficient to fund the services provided under the Plan through its termination but no longer.

EXHIBIT A

The Plan will be executed within the following area: In the central, western, and Scioto Peninsula portions of Downtown Columbus, generally bounded by the CSX railroad tracks directly west of Starling Street to the West, the railroad tracks between Spring Street and Nationwide Boulevard to the Northwest, Ohio Center Way to the North, 4th Street to the East, and I-70 to the South. ARTICLES OF INCORPORATION
OF
DOWNTOWN CENTRAL SPECIAL IMPROVEMENT DISTRICT OF COLUMBUS,
INC.

The undersigned, desiring to form a nonprofit corporation under Chapter 1702 of the Ohio Revised Code, does hereby certify:

FIRST: The name of the Corporation shall be Downtown Central Special Improvement District of Columbus, Inc. (the “Corporation”).

SECOND: The place in Ohio where the principal office of the Corporation is to be located is the City of Columbus, Franklin County, Ohio.

THIRD: The purposes for which the Corporation is formed shall be: (i) to govern the Downtown Central Special Improvement District of Columbus, a special improvement district (the “District”) created pursuant to Ohio Revised Code (“ORC”) Chapter 1710, and (ii) to engage in any lawful act, activity or business not contrary to and for which a nonprofit corporation may be formed under the laws of the State of Ohio, both of which are exclusively for charitable, educational and social welfare purposes within the meaning of Section 501(c)(4) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any future United States internal revenue law) (the “Code”). The Corporation shall have and may exercise all powers of a nonprofit corporation under the laws of the State of Ohio including, without limiting the generality of the foregoing, the power to accept and use gifts, donations, bequests and grants of money and property from public or private sources, to acquire other real and personal property, by purchase or otherwise, to enter into leases and other contractual obligations with public or private entities and to use or pledge the proceeds of such leases and other

contractual obligations in connection with the borrowing of money, and to do all things necessary or appropriate in order to accomplish the foregoing purposes.

FOURTH: The Corporation is formed exclusively for purposes for which a corporation may be formed under the Ohio Nonprofit Corporation Law and not for pecuniary profit or financial gain. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its trustees, officers or other private persons or organizations, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof. The Corporation shall have the power to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment or attainment of any or all of the purposes for which the Corporation is organized, and to aid or assist other organizations whose activities are such as to further, accomplish, foster or attain any such purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except to the extent provided in Code Section 501(h)), and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on: (a) by a corporation exempt from federal income tax as an organization described in Code Section 501(c)(4).

FIFTH: The Corporation shall be controlled and managed under the direction of a Board of Trustees in accordance with the Corporation's Code of Regulations.

SIXTH: The reasons for creating the District include, without limitation, the provision of: (i) supplemental security services that make the District safer and improve perceptions of safety within the District, (ii) environmental maintenance services that are incidental to the District's primary mission to provide supplemental safety services and that make the District cleaner, (iii) homeless engagement and coordination activities that provide thoughtful engagement with people experiencing homelessness or are in crisis in public areas, (iv) maintenance of capital improvements and landscaping that improve the appearance of the District, (v) any other improvements or services that encourage economic development within the District, and (vi) other limited improvements and services in and for the benefit of the District as the Board of Trustees may determine and funds may allow. The public health, safety, peace, convenience and welfare of the District will be enhanced through the District's implementation of the supplemental security services, environmental maintenance services and homeless engagement coordination activities within the District, and by providing cleaning and safety services to the District.

SEVENTH: The territory within the District shall be generally described as that portion of the City of Columbus, Ohio, which is located within the following general area:

Assessable properties are located in the central, western, and Scioto Peninsula portions of Downtown Columbus, generally bounded by the CSX railroad tracks directly west of Starling Street to the West, the railroad tracks between Spring Street and Nationwide Boulevard to the Northwest, Ohio Center Way to the North, 4th Street to the East, and I-70 to the South . The common denominator of these properties is that they are in the general vicinity of the supplemental cleaning and security, homeless engagement coordination, and landscaping improvements in the central, western, and Scioto Peninsula portions of Downtown Columbus

and share a common interest in having the eastern portion of downtown Columbus kept well maintained, clean, and safe.

Attached as Schedule 1 is a map of the territory of the District. Attached as Schedule 2 is a definitive listing of properties that are included in the District, which are identified by parcel number.

EIGHTH: Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Code Section 501(c)(3) or 501(c)(4) and as an organization or organizations described in Code Sections 170(c), 2055(a) and 2522(a) or to the federal government, or to a state or local government, for a public purpose, as the Board of Trustees shall determine. Any of such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes, or to one or more organizations which are organized and operated exclusively for such purposes, as said Court shall determine to best accomplish the exempt purposes of the Corporation.

NINTH: These Articles may be amended from time to time, in whole or in part, by: (i) the affirmative vote of the majority of the total number of Trustees on the Board of Trustees, at a meeting of Trustees called for that purpose, (ii) receiving approval of the amendment, by resolution, from the City of Columbus, Ohio, and (iii) filing the approved amended Articles and resolution with the Ohio Secretary of State.

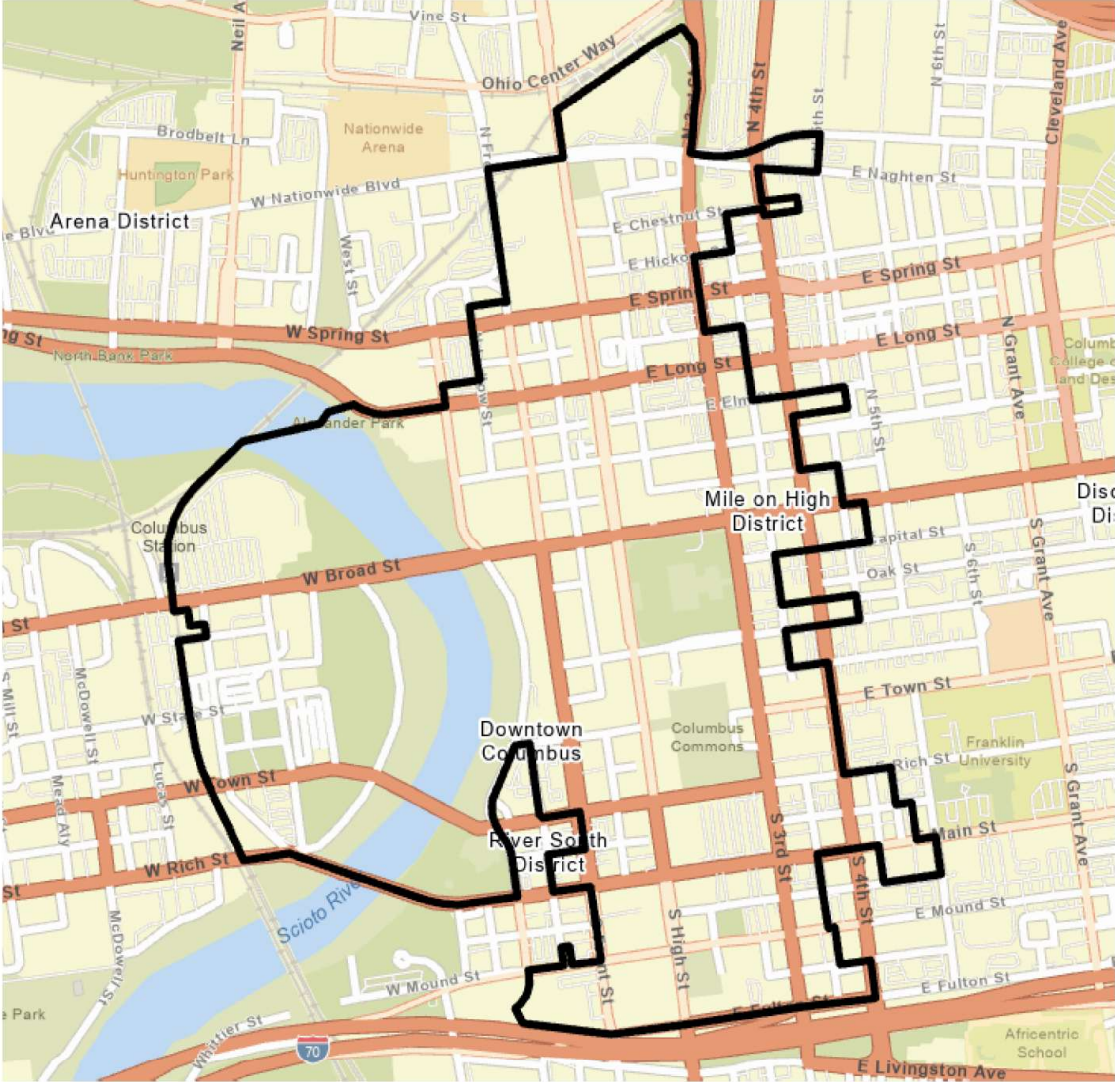
