# 4. A full description of all work to be performed including a full description of work to be performed during any known phasing of the contract

R.D. Zande & Associates, Inc. will perform construction administration and inspection services for these projects. There is no phasing on these projects.

Construction administration requires the consultant to be the City's representative to the contractor. These services generally consist of maintaining and communicating project information, conducting and recording project meetings, reporting on project progress, verifying the contractor's compliance with required schedules, verifying the contractor's payment requests, evaluating and negotiating proposed changes in the construction work, providing materials testing, coordinating quality control verification work, and other activities as required by the contract.

Inspection services generally include observing and verifying construction work, providing clarifications of the construction documents in the field, responding to contractor's inquiries, documenting needed changes to the construction work, providing evaluations and recommendations on the acceptability of the contractor's work, maintaining as-built drawings of the facility being constructed for record plan purposes, and other activities as required by the contract.

# 5. A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract, and a projected ending date

This contract will provide construction administration and inspection services over the next three years. Due to the nature of the Ohio Water Development Authority's funding that the Division receives for many of its projects, the Division will be modifying these contracts as loans are received for projects that require services under said contract. These modifications will be numerous due to the staggered date by which projects are bid, and subsequent loan awards are made available to fund the construction services. Projected beginning and ending dates for the construction work on the projects established within this original contract award are March 2006 and September 2006, respectively. There is no phasing on these projects.

## 6. <u>An estimate of the full estimated cost of the contract including a separate estimate of</u> any and all phases or proposed future contract modifications

The contract from which this work is performed covers construction administration and inspection for DOSD projects from 2006-2008. Two firms, DLZ Ohio, Inc. and R.D. Zande & Associates, Inc., were selected; construction services work provided under these contracts will be divided equally between the two firms during the course of the contract. As projects are bid for construction, and subsequent loans are awarded, the Division will submit legislation requesting a planned modification to utilize services under this contract, and the DLZ Ohio, Inc. Contract.
