W. Curtis Stitt was Senior Vice President and Chief Operating Officer of the Central Ohio Transit Authority (COTA), the regional transit authority in central Ohio on April 4, 2011. In this capacity, Stitt is responsible for all aspects of COTA's bus service delivery operations, maintenance and planning departments.

Prior to that April 4, 2011 appointment, Stitt served as COTA's Vice President of Legal & Government Affairs and General Counsel since February 2005. In that capacity, Stitt served as legal advisor to the CEO and Board of Trustees, manager of the legal department, government and legislative affairs counsel and ethics officer. He was responsible for assuring that the company operates in compliance with Ohio and federal laws and regulations and coordinating legal services provided by in-house attorneys and several outside law firms.

Prior to assuming the General Counsel post, Stitt served six years as COTA's Government Affairs Counsel. As Government Affairs Counsel and General Counsel, Stitt leads COTA's federal funding effort that has secured more than \$25 million in federal appropriations for COTA capital projects over a ten year period.

Sensitive to balancing the organization's need to prudently steward public funds and reduce expenses while providing excellent legal services, Stitt reorganized COTA's Legal & Government Affairs Division. Stitt cultivated strong relationships with COTA's outside counsel firms, enabling COTA to continue but modify the ways it avails itself of their expertise. While doing so, he also established an expanded, sound and capable internal team of professionals in the Division by hiring and developing young attorneys and recruiting seasoned lawyers with a diversity of experience necessary to handle COTA's wide-ranging and unique legal challenges. This approach has enabled COTA to reduce its outside counsel expenses by more than 50% from its 2004 record high level. Stitt's accomplishments at COTA were recognized in 2011 as he was named a *Columbus Business First* Top Corporate Counsel finalist in 2011.

Before joining COTA, Stitt held several legal and administrative positions responsible for regulation of financial institutions in the state of Ohio. Stitt served as the first Superintendent of Ohio's Division of Financial Institutions which was responsible for the regulation of 550 Ohio-chartered commercial banks, thrifts and credit unions, and 5,000 consumer finance licensees. He also served as Superintendent of the Ohio Division of Credit Unions and Legal Counsel to the Ohio Division of Banks and Division of Credit Unions. Stitt also served three years as Corporations Counsel for the Ohio Secretary of State and three years as Appellate Counsel in the office of the Franklin County Public Defender.

Throughout his career, Stitt also pursued what he affectionately refers to as his "other full time job." For more than thirty years, he has organized, administered and coached youth track and field programs. In 1987, Stitt founded the New World Track Club, Inc. Since its formation, New World members have won over 130 medals at national championship meets, including eleven gold and sixteen silver medals. A 2003 Jefferson Award Finalist prize recognized Stitt for his volunteer community service with New World Track Club and young people in central Ohio. Stitt was also a 2009 Jewel Award recipient for his development of and work in New World programs.

Under Stitt's leadership, New World uses track and field as its instrument for providing central Ohio children a positive alternative to deleterious conditions confronting them daily. New World programs promote educational opportunities through the *New World College Tour*; recognize its members' individual on-track and off-track achievements through Athlete-of-the-week awards; provide opportunities to travel throughout the country to regional and national championship meets; and encourage activities that help its members develop their full potential as young people. New World

instills in its members the importance of the constant pursuit of excellence in all endeavors, both on and off the track. Collectively, New World programs expose its members to a diversity of positive experiences that help develop "Champion Athletes on the Track and Champion Citizens off the Track." New World's programs have also provided community service by coordinating member participation in the local Meals-on-Wheels program; hosting Track & Field Days for local elementary schools to enhance their physical education programs; hosting (in cooperation with OSU and the Columbus Recreation and Parks Department) Wednesday Night Track @ OSU, a summer series of free, family oriented local track and field meets; and raising funds for the United Negro College Fund through New World participation in the UNCF Walkathon.

Stitt has coached nationally ranked track and field athletes and provided legal representation for a world-class athlete, securing her eligibility in time qualify for the U.S. Olympic Team for the Barcelona Olympic Games where she won a silver medal.

Stitt earned a Juris Doctor Degree from Northern Kentucky University, Chase College of Law in 1979. Stitt is licensed to practice law in state of Ohio, the United States District Court for the Southern District of Ohio and the U.S. Sixth Circuit Court of Appeals. He is a member of the Ohio and Columbus Bar Associations. Stitt also holds a Bachelor's Degree in Political Science from Kent State University. He is a Life Member of the Kent State University Alumni Association.

Stitt is a member of Mt. Olivet Baptist Church and has served a number of community organizations in central Ohio including former board member of the Council for Ethical Leadership, Franklinton Board of Trade and the Gloria Friend (Mt. Olivet) Christian Academy.
