This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Intersection Improvements - Northwest Boulevard at 5th Ave. and King Ave. project.

# Project Scope:

The work for this project consists of improving the safety of two intersections on Northwest Boulevard through the shifting of the left turn lanes along Northwest Boulevard at King Avenue and at West Fifth Avenue by narrowing the existing medians, and other such work as may be necessary to complete the contract in accordance with the plans and specifications

Fiscal Impact: Source of funds is 2013 DPS cash and ODOT grant

Engineer's estimate, including 10% inspection (corrected): \$348,878.27

Low bid amount, including 10% inspection: \$366,613.24.

Difference between engineer's estimate and low bid amount, including inspection: \$17,734.97

Funding splits for the legislation, including inspection:

DPS = \$66,656.95 (\$33,328.48 construction + \$33,328.48 inspection)

Ohio Department of Transportation = \$299,956.29 (\$299,956.29 construction + \$0.00 inspection)

Schedule: Bids were opened March 26, 2013; estimated Council date is May 13, 2013; estimated NTP date is June 5, 2013. The contract has a completion date of July 19, 2013. A time extension may need to be given to the contractor because of a delay in the evaluation process due to the low bid being significantly higher than the engineer's estimate which resulted in the Department requesting additional grant funds from ODOT as ODOT's consultant had prepared the estimate.
