FACT SHEET JANUARY 2011 JENI'S SPLENDID ICE CREAM, LLC

I. STATEMENT OF PURPOSE – Job Creation

The Department of Development recommends a Jobs Growth Incentive of twenty-five percent (25%) for a period of five (5) years for the purpose of opening a manufacturing and distribution facility in the City of Columbus.

II. PROJECT HISTORY

Jeni's Splendid Ice Creams, LLC, founded in 2002, is a family-owned and operated company. The co-founders are Jeni Britton Bauer and her husband Charley Bauer. Tom Bauer, Charley's brother, became a partner in 2003. With their small team, the company makes every batch of ice cream that is served in their four stores in Columbus and shipped to doorsteps nationwide. Jeni Britton Bauer became inspired to make artisan ice creams while working at a French patisserie. Drawing on the practices of a traditional pastry kitchen, Jeni created her own techniques to make American ice creams that are less sweet and more flavorful. Due to tremendous growth through the years, Jeni's has out grown their current facility and must expand into a larger manufacturing and distribution facility to meet the increased demands.

Jeni's Splendid Ice Creams, LLC is proposing to relocate its' manufacturing and distribution facility from Clinton Township into the City of Columbus. The company will purchase and renovate a 5,000 square feet building located at 909 Michigan Avenue, invest approximately \$75,000 in machinery and equipment, and relocate 13 full-time permanent positions, which will be all new to Columbus, and create 2 new full-time permanent positions.

Jeni's Splendid Ice Cream, LLC is requesting a 25%/5-year Jobs Growth Incentive from the City of Columbus to assist in the development of this project.

III. PROJECT INVESTMENT

IV. DECISION & TIMING

The project is expected to begin January 2011 with a scheduled time of completion for March 2011, contingent upon Columbus City Council approval of the recommended tax incentive.

V. EMPLOYMENT

Jeni's Splendid Ice Creams, LLC will relocate its' manufacturing and distribution facilities into the City of Columbus, relocate and retain 13 full-time positions with an annual payroll of approximately \$344,000, which will be new to Columbus, and create 2 new full-time permanent positions. The total payroll to Columbus (retained and new) will be approximately \$409,080.
