LEGAL DESCRIPTION FOR
VACATION OF RIGHT OF WAY

Situated in the State of Ohio, County of Franklin, Section 25, Township 5 North, Range 22 West, Refugee Lands, City of Columbus, being part of a 1.000 acre tract in the name of The First Hungarian Hebrew Congregation, as recorded in Deed Book 363, Page 201, all references being to those of record in the Recorder's Office, Franklin County, Ohio, and being more particularly bounded and described as follows:

Commencing at the northwesterly corner of Lot 5 of Columbus Commerce Center, as shown in Plat Book 45, Page 48, in the name of M.P. Dory Co., as recorded in Instrument No. 200306020163280, and the northeasterly corner of a 1.000 acre tract in the name of Trustee of the Congregation Agudas Achim, as recorded in Deed Book 227, Page 381, said corner being on the northerly line Section 25, and witnessed by a 5/8" inch rebar (found) at a bearing of North 35 degrees 02 minutes 15 seconds West, and a distance of 0.57 feet;

Thence, South 17 degrees 03 minutes 47 seconds East, a distance of 179.86 feet, along the westerly line of said Lot 5, to the southeasterly corner of a 0.500 acre tract, in the name of The Trustees of the Congregation of the House of Jacob and the northeasterly corner of said 1.000 acre Hebrew Congregation tract;

Thence, North 86 degrees 55 minutes 41 seconds West, a distance of 335.54 feet, along the southerly line of said 0.500 acre House of Jacob tract and the northerly line of said 1.000 acre Hebrew Congregation tract, to the existing standard highway easement line of Alum Creek Drive (Width Varies, Road Record 18, Page 205), and also being the **True Point of Beginning** for the area described herein:

Thence, South 26 degrees 24 minutes 17 seconds East, a distance of 142.50 feet, leaving said property line, through said 1.000 acre Hebrew Congregation tract, along said existing standard highway easement line, to the southerly line of said 1.000 acre Hebrew Congregation tract and the northerly line of a 0.500 acre tract in the name of Congregation Ahavas Shalom, as recorded in Deed Book 547, Page 485;

Thence, North 86 degrees 55 minutes 41 seconds West, a distance of 5.21 feet, along said property line, to an iron pin (set);

Thence, North 26 degrees 24 minutes 17 seconds West, a distance of 142.50 feet, leaving said property line, through said 1.000 acre Hebrew Congregation tract, to an iron pin (set) on the northerly line of said 1.000 acre Hebrew Congregation tract and the southerly line of said 0.500 acre House of Jacob tract;

Thence, South 86 degrees 55 minutes 41 seconds East, a distance of 5.21 feet, along said property line, to the **True Point of Beginning**, containing a total of 0.015 acres.

All references being to those of record in the Recorder's Office, Franklin County, Ohio.

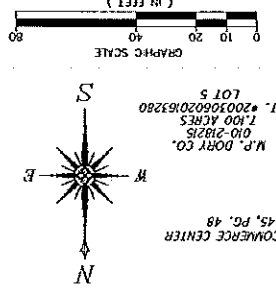
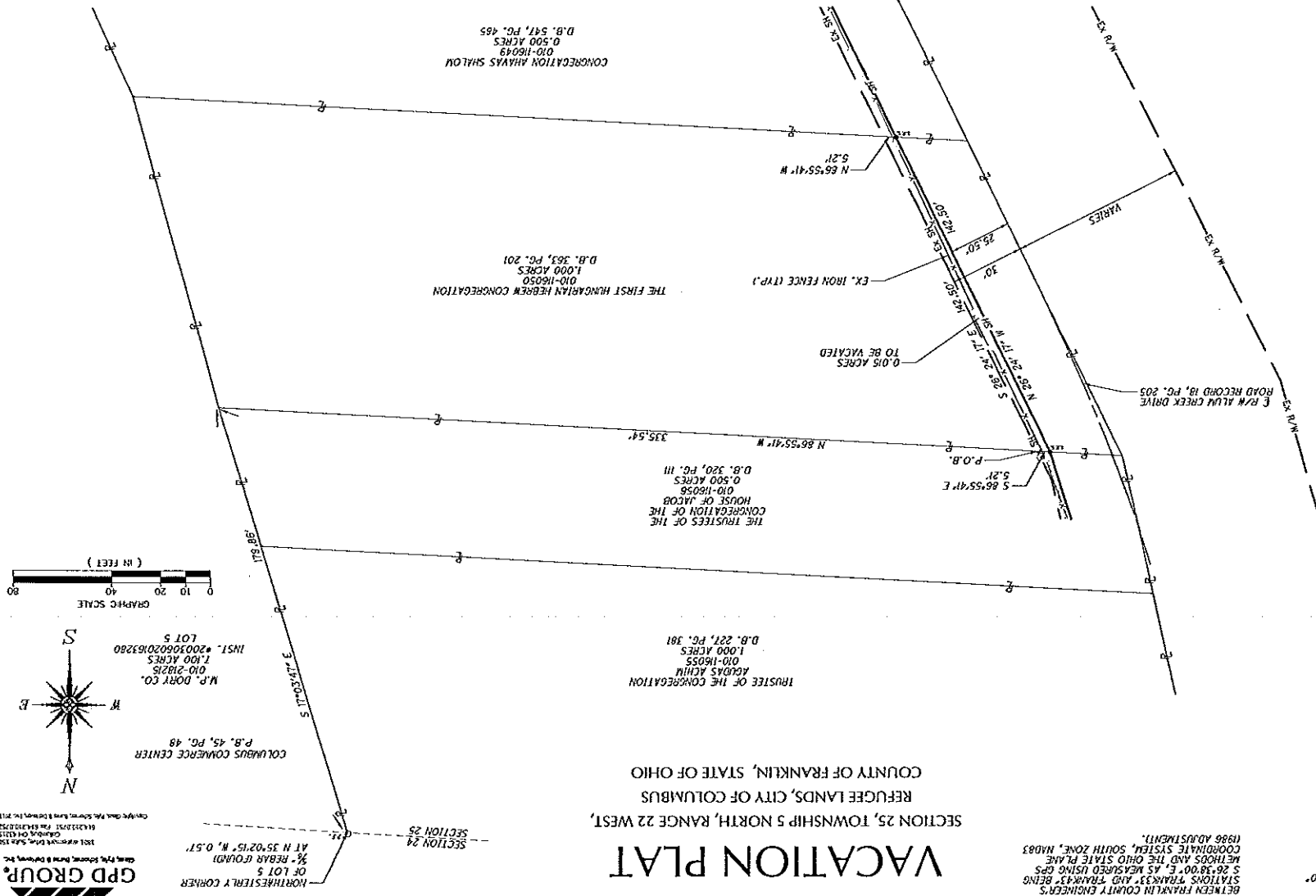
