1. Atwood Terrace/Lenore Avenue Sanitary Relief Sewer Project (CIP No. 650650)
Open cut installation of approximately 1,240 lineal feet of 21-inch sanitary sewer in Atwood Terrace from the alley north of Oakland Park Avenue to Lenore Avenue. This sewer will tie-in to a future 24-inch sanitary sewer (CIP 650649) at the intersection of Atwood Terrace and the alley north of Oakland Park Avenue. This project includes any work necessary to complete the contract in accordance with the plans (CC-13995) and specifications.
2. Atwood Terrace/Northridge Road Sanitary Relief Sewer Project (CIP 650651)
Open cut installation of approximately 550 lineal feet of 18-inch; 795 lineal feet of 15-inch; 455 lineal feet of 12-inch; and 570 lineal feet of 10-inch sanitary sewer in Atwood Terrace from Lenore Avenue to Elmore Avenue. This sewer will tie-in to the terminus of the future 21" sanitary sewer (CIP 650) at the intersection of Atwood Terrace and Lenore Avenue. This project includes any work necessary to complete the contract in accordance with the plans (CC-13996) and specifications.
3. Weldon Avenue Sanitary Relief Sewer (CIP 650656)
Open Cut installation of approximately 1,165 lineal feet of 12-inch sanitary sewer in Weldon Avenue from Atwood Terrace to Melva Avenue. The proposed 12-inch sanitary sewer will intercept flows from existing 8-inch sanitary sewers. The proposed relief sewer will discharge into a 30-inch sanitary relief sewer (CIP No. 650648) in Atwood Terrace. This project includes any work necessary to complete the contract in accordance with the plans (CC-13997) and specifications.
4. Lenore Avenue/Huy Road Sanitary Relief Sewer (CIP 650657)
Open cut installation of approximately 1,162 lineal feet of 12-inch and 1,629 lineal feet of 15-inch sanitary relief sewer to be placed in Lenore Avenue, Karl Road, Huy Road, Gerbert Road and Carolyn Ave. The proposed sanitary sewers will intercept flows from existing sanitary sewers. The proposed relief sewer will discharge into a 21" sanitary relief sewer (CIP 650650) in Atwood Terrace. This project includes any work necessary to complete the contract in accordance with the plans (CC-13998) and specifications.
5. Atwood Terrace Improvements, Piedmont Rd. to Norris Drive, 1990 Dr. E.
This is a roadway improvement project that will be incorporated into the above sanitary relief sewers, and will be funded with capital proceeds from the Division of Transportations bond fund.

A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date. All work included within the aforementioned construction contracts are to be completed within 425 days after the effective date of the Notice to Proceed. No other phases are anticipated for these projects at this time.

An estimate of the full estimated cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

The Division does not anticipate any future work under this contract. The contract amount as shown on the lowest, best, responsive and responsible bid submitted by the Kokosing Construction Company, Inc., is \$44,249,726.25.
