thence South 03° 24' 27" West, across said 170.772 acre tract, a distance of 1266.39 feet, to a point in the southerly line of said 170.772 acre tract;

thence North 86° 44' 00" West, with said southerly line, a distance of 56.56 feet, to the easterly right-of-way line of Ashville Pike;

thence North 03° 40' 48" East, with said easterly right-of-way line, a distance of 981.71 feet, to a corner of said existing easement;

thence South 86° 19' 12" East, across said 170.772 acre tract, with the southerly line of said existing easement, a distance of 25.00 feet to a point;
