St. Mark’s UMC is an inclusive congregation serving both English and Spanish speakers of diverse social and economic status, race and ethnicity, sexual orientation and developmental ability.

Pastor Nancy currently serves on the Executive Board of the Westland Area Business Association, is a member of the Westland Area Ministerial Association and a Corporate Member of the Greater Hilltop Area Shalom Zone, serves on the Inclusive Body of Christ Leadership Team of the West Ohio Conference of The United Methodist Church and is a facilitator for the Kaleidoscope Institute.
