All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of a southerly line of said2.6755-acre tract and the easterly right-of-way line of Lockbourne Road located 30.00 feet RIGHT of station 78+39.09;

Thence North 03°54'25" East, along said right-of-way line, a distance of 231.39 feet to a point in the northerly line of said 2.6755-acre tract located 30.00 feet RIGHT of station 80+70.48;

Thence South 85°26'25" East, along said northerly line, a distance of 5.00 feet to a point located 35.00 feet RIGHT of station 80+70.42;

South 03°54'25" West, parallel to said right-of-way line, a distance of 231.39 feet to a point in the aforementioned southerly line of said 2.6755-acre tract located 35.00 feet RIGHT of station 78+39.04;
