Situate in the State of Ohio, County of Franklin, City of Columbus in the Quarter Township 3 of Township 1, Range 18, United States Military Lands, and being part of Lots 101 and 102 of Crestview as recorded in Plat Book 8, Pages 11-A and 11-B of the Franklin County Recorder's Office, also known as being part of the property conveyed to Richard W. Tishma and Ciara R. Heckaman by Instrument Number 202009170139739 of the Franklin County Recorder's Office, (Franklin County Auditor's Parcel Number 010-035816-00), being Parcel 11-WD on the left side of the existing centerline of Right-of-Way of Indianola Avenue (Right-of-Way 60') as shown on the City of Columbus Right-of-Way Plans for Indianola Avenue (1908-A) and being more particularly described as follows:

Beginning for Reference at a Monument Box Set at the intersection of the centerlines of Indianola Avenue and E. Weber Road (Right-of-Way 60'), said point being Station 134+51.00 of the centerline of Right-of-Way of Indianola Avenue. Thence, along said centerline of Right-of-Way of Indianola Avenue, South 03 degrees 13 minutes 22 seconds West, 162.20 feet to a point in said centerline of Right-of-Way of Indianola Avenue, said point being Station 132+88.80. Thence, leaving said centerline, North 86 degrees 46 minutes 38 seconds West, 30.00 feet to the northeast corner of said Lot 101, the same being the southeast corner of Lot 100 of said Crestview subdivision, said point also being 30.00 feet left of Station 132+88.80 of said centerline of Right-of-Way of Indianola Avenue and the **True Point of Beginning** for the parcel herein described;

Thence, along the easterly line of said Lots 101 and 102, the same being said existing westerly Right-of-Way line of Indianola Avenue, **South 03 degrees 13 minutes 22 seconds West, 53.00 feet** to the southeast corner of said Lot 102, the same being the northeast corner of Lot 103 of

said Crestview subdivision, said point being 30.00 feet left of Station 132+35.80 of said centerline of Right-of-Way of Indianola Avenue;

Thence along the common line of said Lots 102 and 103, **North 86 degrees 46 minutes 47 seconds West, 1.00 foot** to a Mag Spike Set in said common line, said point being 31.00 feet left of Station 132+35.80 of said centerline of Right-of-Way of Indianola Avenue;

Thence across said Lots 101 and 102, **North 03 degrees 13 minutes 22 seconds East, 53.00 feet** to an Iron Pin Set in the northerly line of said Lot 101, the same being the southerly line of said Lot 100, said point being 31.00 feet left of Station 132+88.80 of said centerline of Right-of-Way of Indianola Avenue;

Thence along common line of said Lots 100 and 101, **South 86 degrees 46 minutes 47 seconds East, 1.00 foot** to the **Point of Beginning**, containing 0.001 acre (53.0 sq. ft), more or less, all of which is in Franklin County Auditor's Parcel Number 010-035816-00.

Subject to all, legal, easements, rights-of-way, conditions and restrictions.
