

## Selected Projects

**Ohio Statehouse** – restoration, renovation and addition to the National Historic Landmark state capitol building; including historical analysis, master plan, programming, space planning, architectural design, code analysis, ADA compliance, systems integration, and state Veterans Memorial; recent projects include rotunda restoration as well as incorporation of a new museum; ongoing services as the designated Architect-of-the-Capitol; Columbus, Ohio

**Joseph P. Kinneary U.S. Federal Courthouse** - IDIQ design service contract with GSA, work has included the reallocation of 68,000 sq.ft. of offices and public spaces included space design, specifications, cost estimating, construction documents, and contract administration, designed new millwork and complete courtroom furnishings, electrical modifications/replacement, new HVAC system, ADA modification, fire protection, window replacement, and interior stone repair/replacement, Columbus, Ohio

**Ohio Judicial Center** – restoration, renovation and adaptation of a 415,000 sq. ft. state office building to house the Supreme Court of Ohio; including architectural and engineering design, programming, space planning, code analysis, ADA compliance, new systems integration, Columbus, Ohio

**Minnesota State Capitol** – architectural design in addition to mechanical and electrical engineering services for the design of the interior restoration and preservation, Minneapolis, Minnesota

**Kansas Statehouse** – master planning, renovation, and restoration design for the Kansas State Capitol; restoration efforts included life safety improvements, sensitive replacement of HVAC and electrical systems, and accessibility improvements; Topeka, Kansas

**Utah Capitol Building** – master planning, renovation, restoration including seismic base isolation for this 1912 building, including replacement of all engineering systems; Salt Lake City, Utah

**U.S. Embassy, New Dehli, India** — development of a comprehensive master plan for all properties owned or leased by the US Government in New Dehli; involved space needs analysis, security evaluations and recommendations, a property management plan, and evaluations and recommendations regarding leased vs. owned properties; New Dehli, India

**Lazarus Revitalization** — public/private partnership to renovate a 6-story, 1 million square foot former retail building to become mixed-use space; involved exterior restoration, window replacement, new elevators, and new building systems; LEED Gold CS Certified renovation; Columbus, Ohio

**Old Montgomery County Courthouse Restoration** - reuse of historic courthouse as a community and conference center; involved extensive stone repointing, new lighting, electrical systems, finishes and mechanical systems, Dayton, Ohio

**Fort Hayes High School** – adaptive use of five historic buildings, totaling 168,000 sq. ft., for classrooms and education-related spaces, work includes new building systems, ADA accessibility, Columbus, Ohio

**Reese-Peters House** - restoration/adaptive use, (funded by the Ohio Arts Facilities Commission), conversion from residence to a decorative arts museum/cultural center including upgrade to fully comply with Ohio Basic Building Code and ADA (new elevator, restrooms and grade-accessible entry in the new addition), renovation elements included complete architectural renovation and systems upgrades with new plumbing, fire protection, HVAC, power distribution, devices, fire alarm/security, and interior lighting (including UV stabilized museum-quality display lighting), Lancaster, Ohio

**Westcott House** – restoration, renovation of Frank Lloyd Wright's 1907 prairie style house, preservation of design, adding modern systems such as HVAC, plumbing, electrical, security and fire protection, in association with Chambers, Murphy and Burge, Architects; Springfield, Ohio
