Sir,

The following investigation was conducted concerning the City of Columbus' 2022 annual objection to **0023900** issued to **Abdullah Mart Inc.**, which is doing business as **Save Way Mini Mart**, located at **2585 W. Broad Street, Columbus, Ohio 43204**. The record owner of said permit is **Adullah Qasim Ansar**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor and Ohio Investigative Unit violations revealed that the permit holder has received the following violations in **2021/2022**:

IMPROPER CONDUCT (DRUG and DRUG PARAPHERNALIA POSSESSION BY THE PERMIT HOLDER)

A review of the Columbus Division of Police records revealed the Division of Police has created **fifty-nine (59)** official police reports concerning incidents at the listed liquor establishment between **January 2021** and **November 2022**. 

These calls for service include responses to robberies, shots fired, persons with a gun, narcotics complaints, persons with outstanding warrants,

overdoses, intoxicated persons needing assistance, assaults, fights, disturbances, and motor vehicle thefts.
