

**CHANGES TO SHOP ORDER #126469 HEAVY RESCUE
FOR
CITY OF COLUMBUS**

The following changes shall be done to shop order #126469 to meet the needs of the City of Columbus Fire Department.

1. The upper body compartments shall be changed to one (1) 72" long x 19" high, two (2) 60" long x 19" high, and one (1) 84" long x 19" high.
2. The HRT reels and hose shall be changed to allow the use of a 10,000psi system.
3. The air cascade system including the fill station and cascade control panel shall be deleted from the truck.
4. The air reel shall be plumbed to the chassis air system.
5. The 12,000# winch shall be deleted.
6. A Federal #EQ2B siren shall be provided and flush mounted in the front bumper.
7. The 12 volt scene lights on the body sides shall be changed from Federal to Whelen 900 series.
8. The exhaust system shall be changed from horizontal to vertical stack.
9. The cab light bar shall be changed from the Federal to a Whelen #9308QLED.
10. The upper and lower level warning lights shall be changed from Federal strobes to Whelen 600 series LED with red lens.
11. Four (4) Power Arc #PA180H lights shall be provided on the rear facing of the body.
12. A 50 amp breaker shall be provided in the breaker box to accommodate power required in L4 compartment for your supplied power unit.
13. One (1) rear facing jump seat shall be deleted and a medical cabinet shall be provided in that location. The cabinet shall be 45" high x 24" wide x 21" deep with a Robinson roll up door.
14. A fixed shall 18" deep with a 2" lip shall be provided from the medical cabinet to the driver's side wall in the rear crew area shall be provided.
15. A storage area below the rear bench seat shall be provided. Access shall be provided through doors on the side of the bench seat.
16. The red paint shall match the color provided by the City of Columbus.
17. A pre-build conference shall be held at Emergency One, Inc. for four (4) people. The trip is included in the proposal pricing.
18. A final inspection trip to Emergency One, Inc. for four (4) people. The trip is included in the proposal pricing.
