To date, all survey and basemap work for the water line project is complete. The preliminary design report is nearly completed and the engineer is performing utility locates so that the 30% preliminary design submittal will be complete. Future work includes preparing final construction drawings, bidding project, and completing record drawings. All water main design work has been legislated.
